**Articles of Organization
Of the
St. Anthony Boosters Youth Basketball
Association (NGO)**

We the undersigned, for the purpose of forming a basketball organization, do hereby associate ourselves together as a body and adopt the following Articles of Organization.

Article I

The name of the organization shall be the St. Anthony Boosters Youth Basketball Association, herein after known as BYBA Board of Directors.

Article II: Purpose

The purpose of the organization shall be to develop, enhance, and support the policies and procedures of the St. Anthony Boosters Youth Basketball Program and to provide an opportunity for boys and girls to play the game of basketball, with emphasis on sportsmanship, fundamentals and teamwork, and to provide a favorable atmosphere to fully develop each boy and girl who participates in the program.

Article III

The organization shall not afford pecuniary gain, incidentally or otherwise to its members.

Article IV

The period of duration of this organization shall be perpetual or until such time the SASB becomes insolvent, terminates, or in any way ceases to function as the SASB.

Article V

Article VI

The number of directors constituting the first and subsequent Advisory Board of this organization shall not be less than five (5) nor more than fifteen (15), and the tenure in

The by-laws of the organization duly adopted by the members of this organization shall govern eligibility for membership, eligibility, and term of office for officers and directors and the operation of this organization.

Article XI

The by-laws of the SASB and any future and subsequent amendments to the SASB by laws will supersede the by-laws of this organization, until such time the SASB becomes insolvent, terminates, or in any way ceases to function as the SASB.
