## WAHA Annual Meeting Recap – Mike Hester

### 2011 WAHA Annual Meeting Summary.

#### Meeting in Rothschild WI, May 21, 2011

1. **Region 5 represented fairly well.**
2. Not all numbers being reported to WAHA for cradle roll, counts showed we reduced by 20 players this year?? Are not including Pre Hockey, Ice Mites and ADM.
  - a. Look to adding Growth coordinator for WCYHA
3. **Growth Development**
  - a. Welcome Back Week September 12-18
  - b. Try Hockey for Free November 5
  - c. 2 on 2 Challenge: Maintain 2 players from the U8 group and add 2 more.

**4. ADM Presentation,- On USB drive and disks.**

- a. Good Presentation.

**5. Coaching Changes**

- a. No longer able to do multiple levels of certification in same year.
- b. All coaches, asst coaches, bench help, on ice help, etc must have the required certification level by January 1 of the current season.
  - i. No one can be on the ice without this.
- c. Must certify for Level 1, 1<sup>st</sup> year, Level 2, 2<sup>nd</sup> year, Level 3, 3<sup>rd</sup> year until etc....Must reach Level 4 by 9<sup>th</sup> year of coaching.
  - i. Level 1 Cert-Level 3 Cert will have classroom and on ice element. All Level 1 and 2 Cert expire annually.
  - ii. Level 3, 4, 5 cert can be re-certified online. Expire every two years.
- d. In addition to the Certification, there will be an age specific component that must be taken for each age level a coach is handling.
- e. Keep paperwork to make sure there is not an error in the On-line system.
- f. Change in Fee structure; Level 1-3 \$40.00, Level 4 \$200-300, Level 5: \$400. Age specific element is \$10 per test.

**6. Pee Wee Checking:**

- a. Move from 11-12 to 13-14.
- b. Reason for the move initially because of loss of skill acquisition from Squirts to Pee Wee's
- c. Want to teach contact confidence.
- d. Change Coaching, Ref, and Umpire requirements to teach "legal" body contact for bumping, and angling at the squirt level up through Pee Wees.
- e. 120 hours required to really understand checking. This provides more time to allow acquisition of these skills.
- f. **Utilize USA Hockey website under coaching (Coaching Education Program)**
  - i. Practice Plans (On and Off Ice)
  - ii. Ref Training. Creating Video Rule book.
  - iii. 3 manuals on USA website for body contact.

**7. Classification**

- a. 2 Associations move up:
  - i. Oshkosh division 4 to 3
  - ii. Wash County division 3 to 2
- b. 4 Associations moved down
  - i. McFarland division 1 to 2
  - ii. Marshfield division 2 to 3
  - iii. River Falls division 2 to 3
  - iv. Price Ice division 3 to 4
- c. 1 New Association
  - i. Pettit to division 3
- d. 1 Association being watched.
  - i. Fon du Lac may move from division 2 to 1 in 2012-2013.
