Proposed Amendment: Bylaw 402 Elections

Larry Frisoli was asked to explain why 75% of the membership. Bruno Trapikas motioned to remove the words "and/or the Adult Council, and Dyann Pugliese seconded. Motion carried. There was discussion regarding definition of USASA officers. John Sutter, NTX motioned and Carlos Rodriguez, Region III Director seconded to table the motion as amended. Motion carried.

Elite Player Program (Formerly Select Team Program)

There is a recommendation from the Executive Committee to pass this new program proposal. Marypat Bell motioned and Bill Bosgraaf seconded the motion. Motion carried. (see attached for more information.)

Approval of Minutes from 2007 AGM

Gerhard Mengel motioned and Peter Pinori seconded motion to approve AGM minutes as presented. Motion carried.

New Business

Stephen Flamhaft spoke regarding a USSF rule change proposal that he is submitting for the AGM. He is seeking a non-binding endorsement of support from USASA. His resolution states that the USSF President should be paid an annual salary of \$250,000 and he provided his rationale for this proposal. Werner Fricker spoke in favor of this item. Sal Rapaglia motioned and Peggy Polley seconded that the USSF President should be paid an annual salary of \$250,000. Bruno Trapikas indicated that USASA does not have authority to pass such an item therefore the motion was withdrawn.

Dan Ariail, a new delegate from North Carolina indicated that Park and Recreation Board at the national level is involved with all other sports except soccer. He indicated they tend to be gatekeepers to field availability and share the same mission. He urged the board to consider a partnership with national Parks and Recreation Board. We have already been in dialogue with them. Stephanie Walker is to speak directly with Dan regarding roadblocks at the national level.

Sal Rapaglia voiced his concerns about the Referee of the Year program and requested that the Referee Committee revisit or revise the program eligibility criteria so as not to give the wrong impression.
