I also agree to indemnify and hold harmless the Club for all claims arising out of Participant's participation in the Program and all related activities. I understand that this document is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. In consideration of my child's participation in the program, I, for myself and the player hereby release and indemnify the Club and the owners and operators of any facilities used for practices and games from and against any and all claims, liabilities, damages or cause of action arising with the child's participation in the Program. I am of legal age and am freely signing this Agreement. I have read this form and understand that by signing this form, I am giving up legal rights and remedies.
