



HASTINGS YOUTH ATHLETIC ASSOCIATION AGREEMENT

To complete your child's registration this agreement is to be read and signed by a parent or guardian in order for your child to participate in HYAA sponsored sports. **Only 1 form per family need's to be signed**, unless the player lives in a different home.

1. **REGISTRATION FEE & PROGRAM FEE:** all fees shall be paid in full at the time of registration. If you need financial assistance, contact the President or Treasurer to complete the Application for Assistance.
2. **PAYMENT PLAN:** payments can be set up over a four month period. Contact the President or Treasurer to set up a payment plan, all payment plans need to be paid by June 1 or your child may be taken off of the team! If your situation changes please contact the President or Treasurer and your request will be taken under consideration.
3. **FINANCIAL ASSISTANCE:** If you need full or partial assistance due to special circumstances, contact the President or Treasurer for an Application for Assistance to be filled out by a parent or guardian. Waived fees are limited to 1 per child per year. Waived Fee's will be up to the discretion of the HYAA Board. All reasonable requests will be considered. Older youth (or parent) can earn money to pay fees by umpiring.
4. **NON-VOLUNTEER FEE:** A parent or guardian is required to volunteer hours for each child for each sport. Volunteer opportunities will be posted on our website, under the DIBS section. If you choose not volunteer, then you can pay a non-volunteer fee at time of registration. \$200 for Traveling Softball and Baseball and \$50 for In-House Softball.
5. **LATE FEE:** of \$25.00 shall be charged for each child for each sport.
 - a. For In-House players a late fee will be charged after May 1. Exception: request to register must be within one month of moving into town. **NO REFUNDS!**
 - b. Traveling player's late registration date and refund dates is March 1.
6. **REFUND POLICY:** There will be no refund of any fees if a player drops after:
 - a. March 1 for Traveling Baseball and Traveling Softball
 - b. In-House Softball drop date is May 1If a player drops at any time, the program fee will not be refunded. If no team is available for a youth to participate on, the full registration fee will be refunded. If a player is excluded from participation due to behavioral problems, no refund will be issued. Refunds will be made for medical reasons or relocation reasons. Special cases will be review by the HYAA Board based on a recommendation of the Sport Director
7. **ALL RETURNED CHECK'S WILL BE ASSESSED A \$35.00 CHARGE.**
8. No program fees are refunded. All players with financial assistance must participate in fundraising opportunities by volunteering time. Program fees and fundraisers are used to help cover sport and program cost.
