### **MEMBER AGREEMENT – TRAVEL PLAYER**

This Agreement is made effective \_\_\_\_/\_\_\_\_/\_\_\_\_, between the parent or guardian (“Parent”) and the **Southern Maryland Sabres Hockey Club** (“Club”).

Parent and Player agree that Player shall play for the **Southern Maryland Sabres Hockey Club** for one full season, commencing on or about **August 15<sup>th</sup>** of the current year and ending the following **April 1<sup>st</sup>**. Parent and Player agree that Player shall be actively involved with the Club’s team and no other USA Hockey registered organization, unless approved in writing by the Club. For purposes of this Agreement, “actively involved” shall be defined as participating in all scheduled practice sessions and games in which Player is called upon to participate, unless unable to do so due to illness or other valid reason and in accordance with the stated Attendance Policy in the Travel Member Handbook. Parent and Player agree that the Club shall have the right to release or suspend Player at the discretion of the Club’s Board of Directors in accordance with the Club’s by-laws, approved policies, and other Rules and Regulations. Parent and Player agree that, for Player to remain on the team, Parent and Player must (1) commit no act detrimental to the sport of ice hockey, the Club or the team: (2) comply with all provisions stated in this Agreement: and (3) abide by the Club’s by-laws and other Rules and Regulations.

Upon notification of acceptance to the Club the Parent agrees to pay a non-refundable initial payment **by May 15<sup>th</sup>** of the current year. This payment reserves Player’s spot on the roster. Player’s annual fees must be completed per terms outlined in online registration with all payments made electronically online. No cash will be accepted. Check or money order payments made outside of the Club website system will only be accepted if approved in advance by the Club Treasurer for alternative payment plan purposes only. Failure to adhere to the payment plan may result in Player suspension from all Club and team activities until the Parent/ Guardian has resolved the situation to the satisfaction of the Board of Directors.

Player will not be permanently placed on the team roster until the initial payment has been made. In addition, Parent and Player agree they shall submit all necessary forms, including but not limited to (i) USA Hockey online Program Participation Registration; (ii) Consent to Treat form; (iii) Code of Conduct forms (to be signed by **both** parents, where applicable, and player); (iv) Uniform Order Form (if needed); and (v) Concussion Baseline Testing Acknowledgement (if needed per age guidelines). *Note: a copy of the player’s Birth Certificate may be required for proof of age eligibility.*

Parent and Player agree and understand the Player’s annual fees are intended to cover game, practice, referee costs, one tournament per season, and general expenses. Any costs for additional tournament fees, Player transportation, hotel accommodations, meals, equipment, uniforms, warm-ups, and the like are the responsibility of the Parent/ Guardian.

There is will be **no proration** of any portion of the player’s fees due to participation in another sport and/or activity that conflict with the current season. The Parent shall be responsible to pay the **entire Player’s fee**. There will be **no refund** of any portion of the player’s fees and the Parent shall remain responsible to pay the **entire Player’s fee** even if, after execution of this Agreement, Player withdraws from the Club for any reason, including injury. (The Board reserves the right to deviate from this policy under circumstances that in its sole discretion it finds extraordinary and compelling.) Parent and Player understand that the Club will not issue a Release to any Player whose Parent has outstanding financial obligations to the Club.

Parent and Player understand failure to meet any of the obligations set forth in this Agreement shall be grounds for suspension of Player’s participation in the activities of the Club and team, until such obligations have been fully met.
