



## Arapahoe Ice Warriors Booster Club Meeting

### **Minutes from March 12, 2015**

**MOTION:** Lori Lomen made a motion to approve the March 12, 2015, minutes. Jill Hanafee seconded. All in favor, motion carried.

### **Treasurer's Report:**

Jeff Berven reported on Nancy Fulton's email update as follows: the current available balances are \$18,590.38 in the main account, and \$104.11 in the raffle account. FirstBank signature card has been updated with new officers' signatures/information (Jeff Berven and Catherine O'Grady).

### **Old Business:**

- **Snapbooster Texting Fundraising:** February Snaps check for \$65.48 received and deposited into the Booster Club general funds account. Discussion regarding the break-out of Snap codes per team (instead of for the whole of the Booster Club) is tabled until the next meeting.

### **New Business:**

- **CCYHL:** Tryout dates for 2015-2016 season announced as follows (no earlier than):
  - Midget – 8/1, Bantam – 8/28, Peewee – 9/8, Squirt – 10/1
  - Midget Minor AA will be full season, while Midget Major AA will remain half season. Midget A will breakout as follows: Minor – U16 and Major – U18.
  - Free agents – A maximum of four players per age level will be allowed as new members of an organization (not to include out-of-state or independent players). This will be up for vote at the May meeting.

- 2015-16 season registration is on hold until free agent issue is resolved (expected to open in mid-May).
- Coaches for AYHL 2015-2016 season should be finalized by late April. Sixteen teams – four at each level.
