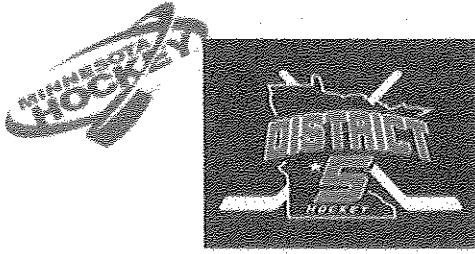
Open Floor-
