



# Disciplinary Actions Agreement

Fond du Lac Youth Basketball Club, Inc.

1. **If a player is consistently late to practice, the consequences will be:**
  - a. Coach’s discretion: if it becomes a consistent reoccurrence and the coach is unable to resolve, then the player/parent/coach will meet with the Board to discuss and find a resolution.
2. **If a player receives a technical or flagrant foul during the season, the consequences will be:**
  - a. The coach or team manager will need to inform the Board of the occurrence. If the referee was quick to make the call, then the coach will have the right to decide what the disciplinary action will be. If the technical was warranted or the flagrant foul was vicious, then the player will be unable to participate in the next game. Second occurrence, and the technical or flagrant foul was warranted, the player will be unable to participate in the next tournament. Third occurrence, the player will be banned from the program the remainder of the season.
3. **If a player/parent/coach is ejected from a game, the consequences will be:**
  - a. Player Ejected: The coach or team manager will need to inform the Board of the occurrence. The player will be unavailable for the next game. Second occurrence, a meeting with the coach/player/parents/executive board will be required before the player can practice or play. The board will determine his/her availability for the next tournament. Third occurrence, the player will be banned from the program the remainder of the season.
  - b. Parent Ejected: The coach or team manager will need to inform the Board of the occurrence. The parent will be given a warning. Second occurrence, a meeting with the coach/parents/executive board will be required before the parent could attend another game. Third occurrence, the parent would be banned from attending any future game.
  - c. Coach Ejected: The coach or team manager will need to inform the Board of the occurrence. The coach would need to apologize to the parents and players before the next practice. Second occurrence, a meeting with the coach/executive board will be required before the coach can practice or coach a game. The board will determine his/her availability for the next tournament. Third occurrence, the coach will be banned from the program the remainder of the season.
4. **If a player is consistently disrespectful to his or her coach, the consequences will be:**
  - a. This will be left up to the coach’s discretion. If it becomes an issue and the coach is unable to resolve, then the player/parents/coach will meet with the Board to discuss and find a resolution.
5. **If a player or parent is using any social media to BULLY, or put a player or a coach down, the consequence will be:**
  - a. **Player:** First offense and the player/parent/coach will meet with the Board to discuss and decide availability of the player. Second occurrence, the player will need to write an apology to the recipient, before they can participate in practice. He or she will also be unavailable for one tournament. Third occurrence, the player will be banned from the program the remainder of the season.
  - b. **Parent:** First offense and the parent will not be allowed to attend one tournament. Second occurrence, the parent will not be allowed to attend any games for the remainder of the season. If it continues the police may become involved, and at which time the Board will relinquish the necessary information upon request.
6. **Citizenship:**
  - a. If a student athlete is in chronic trouble in school during the season, or is in trouble with the police department; the player will be suspended for (1) tournament. If violations continue, or issues with the police, or if any of the violations are a physical altercation in any form, the player will be suspended for the remainder of the year and will forfeit all registration fees. Equipment deposits will be returned in full once jerseys have been returned cleaned, and in satisfactory condition. If a player is suspended from school at any time during the basketball season, the player will be ineligible to play at the next scheduled tournament.

**\*\*\*If a violation occurs on the last day of competition for any of these items, the consequences can/will be carried forward to the ensuing season for up to a minimum of 4 tournaments\*\*\***
