A. Opening Round / Call to Order

B. Review of Prior Meeting Minutes

C. Treasurers' Report

D. Presidents' Report

training.

<u>D.01:</u> Fall League went well. The HS team had a few free agents who drifted to us from Homegrown. Also had U11, U13 and U15 teams. U11 had Minneapolis players and coaches—they ended up paying for the Pumpkin Shootout for the team. Biggest complaint heard from parents was that there were no practices. Could provide three options in the future: those kids that can't attend practice, those that maybe can and those that always can. Other sports schedules can conflict with this in the fall.

<u>D.02</u>: MBSLA general membership meeting is Saturday, November 14. Scott Tapio will attend, and Kevin Flynn may as well.

<u>D.03</u>: Chris Larson and Kevin Flynn attended a YLM Meeting on November 8th.

US Lacrosse suggesting that U11 may revert back to 7x7 at B level and any new teams at the A level (currently a 9x9 format). Benefit would be 2 games on one field, therefore needing fewer refs. YLM also thinking to have quarterly meetings instead of having one annual December meeting. Object of that would be to address issues as they arise, better advanced planning and more face to face communication.

YLM also requesting that EMT's be at all YLM sanctioned games. EMT's scheduled through YLM would cause the fee to go up. Other option would be the Associations to provide them for games Coaching and training of coaches and officials was also brought up. Question is if the YLM can provide training for new coaches and coaches that have not been through training.

The YLM Annual Meeting will be held on Sunday Dec. 6th.

<u>D.04:</u> Chris Lyons attended the MS Lax meeting. They will be reforming the 5/6 to 7x7. They will run three clinics over Christmas break—each one would be about \$75. E.03b Spring Leagues. Several St. Anthony families (Murray school kids) have played through Minneapolis in the past have inquired about playing for St. Paul in a spring league. YLM will hold a Spring Jamboree for low cost or free. 3 weekends in 4 weeks in April/May and outdoors. GNLL will have an indoor box league March 12-April 24 with a tourney the following weekend. It is intended to go from box to summer (May-June) to summer. This would be in Hopkins. Sota Lax will have box lacrosse in the spring that does not require special gear. Will be 6x6 indoor and run April 1-May 1. YBL will have true box and also 6x6 from late February to early May.		
If SPLAX affiliates with a league, location will be very important—going to Rochester and Hastings last year was hard for many. Need to decide what program to go with, what age groups, and cost. Will need coaches as well. Kevin mentioned spring league could possibly be used for evaluations.
