Coach has to be carded for that team.</li> <li>✓ U-9's playing at BNSC home fields on August 24, 2003 at 1:00 pm – All clubs should send a representative for education opportunity – No cost to teams covered by education fund for CIYSL. Ref fees will be taken from CIYSL education fund. Referee costs are split.</li> <li>✓ Must use an assigner for refs</li> <li>✓ U-9 and U-10 can go to tournaments that give awards</li> </ul> | <p>Jay Ray will meet with U-9 teams to discuss roster size.</p> <p>Bloomington Independent U-12 boys team requested out of town teams to help pay for Sale Barn fees. Host teams pay all field fees and ref fees are split.</p> |
