Coaches Conduct/Policy Review

BSC will be developing a coach's conduct/policy that will outline what is required of coaches. This will become part of registration. Ollie is working on this and will be reviewed by the board.

Discuss specifics on Merger and vote

Reasoning: To provide a unified top quality soccer experience for all youth soccer players in the Wright County area with a unified, positive vision and purpose.

Desired Result: The result would be a club that provides soccer players of all talent and commitment levels with a vibrant recreational program and a competitive travel program, along with additional optional programs such as open soccer, winter training and summer camps. Having all the options under one roof <u>minimizes community confusion</u> and <u>maximizes cohesion</u> and in turn <u>elevates local soccer</u> playing potential.

Benefits: In addition to the benefits listed above, instead of having two entities competing for scarce resources, the result will be <u>one entity providing a broad set of soccer options</u>. Resources include, but are not limited to:

- Referees
- Coaches
- Volunteers
- Field space
- Soccer Expertise

- Players
- Access to The Edge for BSC Activities.

Merging would also eliminate the confusion that surrounds the different programs and would allow us to market soccer in a much more effective and cohesive way to our local players. With the "conflict of interest" gone, players would be free to choose their preferred program(s) and the club would be working to provide the best experience for them however they choose to participate. The "us" and "them" mentality would fade and the "we" mentality would take root.

The BSC Soccer club would run as it currently has. The following would not change.

- Registration Fees for Rec
- O Number of divisions will not change unless dictated by numbers.
- O Game nights and field locations will not change
- O No drastic changes are on the agenda.
- **Our Current BSC Equipment would be used for the Recreational Program.**

A motion was made by Ollie...

"I would like to motion that we the board members of the Buffalo Soccer club disband the corporation Buffalo Soccer Club Inc. The club itself, Buffalo Soccer Club will still exist as part of Wright County and will continue to serve the Soccer community as it has for many years. For tax purposes the Assets of Buffalo Soccer Club Inc will be distributed to Wright County Soccer, Inc."

The motion was passed by a vote of 8-2.

Wright County will be voting on this topic at their AGM – Nov 20, 2016. If they agree to merge with BSC talks outlining the details of the merge and Board Assignments will be discussed.

If Wright County chooses to merge the board will be made up of current board members from both clubs until elections could be held to elect a board. Elections should take place within 12 months of the merger becoming official. The current club presidents would alternately assign current board members to positions as necessary to fill the new club's interim board positions, ensuring equal representation from both clubs.
