I understand that volleyball involves certain risks, including but not limited to possible neck and spinal injuries, and injury to virtually all bones, joints, muscles, and internal organs. I further understand that volleyball involves a particular high risk of knee, shoulder, and neck injury. In addition, I understand that participation in volleyball involves activities incidental thereto, including, but not limited to travel to and from the site of the activity, participation at sites that may be remote from available medical assistance, and the possible reckless conduct of other participants. I am voluntarily participating in this activity with knowledge of the danger involved and hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

I also give my permission to have any photographs taken of me during Excell Sports activities published on the EXCELL SPORTS website and/or other social media outlets.

I further agree to indemnify and hold harmless Excell Sports, LLC any and all venues, coaches, representatives and any and all other associated entities from any and all claims arising as a result of my engaging in or receiving instruction in volleyball activities or any activities associated with my participation in the volleyball lessons, wherever, whenever, or however the same may occur.

I understand that this waiver is intended to be as broad and inclusive as permitted by the laws of the State of South Carolina and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further affirm that the venue for any legal proceedings shall be in the State of South Carolina.
