\*NOTE: Off ice strength training will be mandatory for all U16 and the upper bantam players. Strength training location and times will be determined and fees will be collected at a later date.

**\*\*NOTE:** Once the rosters are announced on the Frederick Freeze website [www.frederickfreeze.com](http://www.frederickfreeze.com), this Financial Agreement goes into effect. To decline a roster position, the player must notify the head coach, hockey director and treasurer that the position will not be accepted, and this must be done within 24 hours of the roster announcement. If the player chooses not to accept a position on a team within the 24 hour decline period, the initial deposit will be refunded. If the Financial Agreement is not in the Club's possession by the start of the last tryout session the Player will not be allowed on the ice or be eligible to be selected for a roster spot on any club travel team. If a Player is selected for a travel team, and chooses not to participate in the Club travel program after the 24 hour decline period, the Parent will forfeit the entire team amount in order to receive a release. Once a roster position is accepted, you will be asked to complete a second online registration to make arrangements to pay the balance of the season fees. You will have the option to pay for the full season fees or to set up a payment plan. The season fees must be paid in full by September 1, 2018.

Parent and Player agree that Player shall play for the selected team for one full season, commencing May 12<sup>th</sup>, 2018 and ending March 9<sup>th</sup>, 2019. Parent and Player agree that Player shall play for no other USA Hockey registered organization (except for a high school team) unless approved in writing by the FYHA Club. Player agrees to be "actively involved" with his/her team, which shall be defined as participating in scheduled practice sessions and games of his/her team unless unable to do so due to injury, illness or other valid reason.

Parent and Player agree that the Club shall have the right to release or suspend Player at the discretion of the Club's Board of directors for not fulfilling this agreement. In accordance with the policy set forth by the CBHL, players with outstanding obligations to the FYHA will be submitted to the CBHL. Parent and Player agree that for the Player to remain on the team, Parent and Player must (1) commit no act detrimental to the sport of ice hockey; (2) comply with all provisions stated in this Agreement; and (3) abide by the Club's rules, regulations and decisions of the Board of Directors.

Parent and Player agree and understand the above described program fee is intended to cover ice costs and general expenses of the Club. Any additional costs for transportation, hotel accommodations, meals, equipment, particularized team fees, uniforms, warm-ups and the like are the responsibility of the Parent.

Parent agrees he/she is obligated to pay the entire program fee upon the effective date of this Financial Agreement. For the Convenience of the Parent, the player fee may be paid in installments outlined herein; nevertheless, Parent understands the obligation to pay the entire player fee arises as of the effective date of this financial agreement and survives termination thereof.

Parent shall remain responsible to pay the entire fee, including any unpaid installments, even if, after the effective date of this Agreement, Player withdraws from the Club. (The Club's Board of Directors reserves the right to deviate from this policy under circumstances that in its sole discretion it finds extraordinary and compelling.)

Parent and Player understand the Club will not issue a release to any Player whose Parent has outstanding financial obligations to the Club. Parent and Player understand that the failure to meet any of the obligations set forth in the Agreement shall be grounds for suspension of Player's participation in the activities of the Club and team until such obligations have been fully met.

In signing this Agreement, Parent acknowledges that he or she has read the Agreement and understands it fully and willingly accepts the financial and other obligations, which this Agreement confers.

This is the entire Agreement between the club and the Player and his or her Parent(s), and Parent understands this Agreement is the sole agreement controlling payment of fees and refunds. This Agreement may not be modified except by written agreement signed by all parties to this Agreement.
