With the new registration cost charged to players to play in the Jr A league a few years ago there has been a filtering down effect to the Jr B & Jr C levels where registration cost to players is significantly less. When you combine this filtering down effect with the loss of Jr D hockey a few years back it is becoming very difficult for local kids to play on their local Jr C team. With the age for Jr A, B, & C being 18, 19 & 20 year olds and with the OMHA's aim of "providing sport for the greatest number" it just seems natural that we as hockey parents would like our 18-20 year old kids to keep playing hockey whether that be Jr or juvenile. If we can change the age we keep more kids playing hockey longer and it would also help small rural centres who maybe can't get quite enough local kids to ice a juvenile team thus increasing the number of juvenile teams and therefore creating leagues with more robust numbers.

<u>Exception</u>: If a player rostered as an NRP subsequently becomes eligible to play for the rostering team in accordance with OMHA Regulation 3.5.a.ii due to the NRP's home Centre not being able to provide a representative team for which the player is eligible by age and residency, the NRP status will no longer apply to that player. This player will be eligible to play for the rostering team in accordance with OMHA Regulation 3.5.a.ii and the rostering Centre may choose another NRP to replace that NRP.

RATIONALE

OMHA Regulations 3.5.a.ii and 3.5.c.iv are potentially contradictory. When a Centre cannot provide a representative team for a player, OMHA Regulation 3.5.a.ii allows the player to tryout for the representative team at the next nearest Centre to the player's residence. It does not make sense that a player eligible to play for a Centre by residency be identified as a Non Resident player.

A purpose of the NRP program is for players to play with other players with similar skill sets; however, the limit of three (3) NRP's per team can limit the success of achieving this goal. If a

team choses an NRP that subsequently becomes eligible to play for the rostering team by residency it should open up an opportunity for another player to play on a team with a skill set similar to their own. Allowing a replacement for that NRP goes toward achieving this goal.

Similarly, limiting the opportunity for players to play up on teams with other players with skill sets similar to their own can result in a particular player or players dominating the games they play in. In this situation, it is probable that no players on the team are developing their hockey skills over the course of the season. It is also highly probable that the less skilled players on the team and their opponent's team are not having fun. Allowing for the replacement NRP will help to mitigate these unwanted situations.

Also, due to logistics of ice time and rostering teams prior to the commencement of league play, many teams host try-outs in the spring. OMHA Regulation 3.5.d.x requires teams to offer the player an opportunity to sign a letter of commitment within 14 days of the commencement of the team's tryouts. Hence NRP decisions for these teams are made in the spring; however, decisions to not provide a representative team at a particular age group are often not made until the fall. This results in not all player information being available until after decisions about NRP's are made. It makes sense that teams be provided an opportunity to make adjustments as information becomes available. It follows then that allowing NRP's that become eligible to the team by OMHA Regulation 3.5.a.ii to be replaced with another player with NRP status makes sense.

- 5. When a player's home centre is base category AAA, AA or A, after fulfilling all tryout commitments at his home centre, a player may tryout for (1) OMHA BB or below base category centre. To be eligible the player is required to be the Minor Peewee age (eleven (11) years old) or older as of December 31st of the current playing season; OMHA Regulation 3.6 is Not applicable. Maximum number of rostered "Non Resident Players" (NRP) is three (3) per eligible team. Once a team has rostered an NRP then NO replacement NRP will be permitted.

- i) As per current Regulations no tryouts or on or off-ice activities directly or indirectly (including skating parties, conditioning camps, refresher programs, etc.) may be conducted prior to the completion of the OHF Minor Hockey Championships. (OHF Regulation G).
- ii) Eligible players, upon pre-registration with their Home Centre for the upcoming season, must request a Non Resident Player (NRP) Passport to be eligible for the

- process/tryout. The Home Centre verifies that the player is eligible by age/residence for their Home Centre and authorizes the NRP Passport.
- iii) If the player attends his Home AAA Zone tryouts and is not offered a roster position he may then exercise the option to attend tryouts at a Centre as outlined under OMHA Regulation 3.5c) Additional Method of Player Movement for Non Residential Players and/or request an OHF AAA Waiver per current Regulations.
- iv) If the player chooses to exercise his option to try out for a BB or below Centre as per OMHA Regulation 3.5c) Additional Method of Player Movement for Non Residential Players, that AA or A Centre must validate the player's attendance at tryouts on the NRP Passport.
- v) If the player is not offered a roster position at his chosen option of BB or below base category team he **MUST** return to his Home Centre.
- vi) If the player is offered a roster position at his chosen option of BB or below he MUST return to his Home Centre at the end of each season. (Permission is for one (1)season only).
- vii) The NRP Passport is retained by the Centre/Team for which the player rosters and MUST be uploaded to the player's profile.
- viii) The BB or below Centre/Team with which the player rosters **MUST** notify the Home Centre by October 31st of the current season.
- ix) A team must offer a player the opportunity to sign a "Letter of Commitment" for the current season within fourteen (14) days of the commencement of the team's tryouts or October 31st, whichever is earlier.
- x) No player may be signed as a NRP after October 31st of the current season.
- xi) A team cannot release a signed player after November 15th, without the agreement of his Home Centre, in writing. Any such release shall be to the player's Home Centre only.
- xii) A player requesting his release back to the Home Centre must do so, in writing, to the Rostering Centre and the Home Centre.
- xiii) There will be no movement of players after December 1st unless agreed by the player's parents, the Rostering Centre and the Home Centre, in writing.
- xiv) Player Movement and the process will be reviewed yearly.

6.1 d) iii) Every OMHA team registered on an electronic roster must have on the bench at the start of and during the game (unless ejected from the game) a certified and registered coach and a certified and registered trainer, as well as 1 other bench staff being a certified and registered coach or trainer, at the Novice, Atom and Peewee levels. In addition, other qualified and registered officials of that team may sign the game sheet and be on the bench at the start of and during the game. There shall be no more than five (5) team officials signed to the official game report and on the bench during the game.

RATIONALE

This is becoming a player safety issue, as well as a Risk Management issue for some Associations. At the younger levels, players are more prone to accidental collisions, trips and falls into the boards. They are also more likely to not be able to verbalize a suspected injury, be it a sprain, break or possible concussion. A mandatory 3rd official at these lower levels would be able to focus completely on the injured player while the other 2 members of the staff can focus solely on the remainder of the game, knowing that the player is getting

RATIONALE

Each year, for at least the past five (5) years, some seven hundred (700) HCOP officials leave/quit the OMHA referee program. Each year there are some seven hundred (700) new officials who enter the OMHA referee program through clinics and the OMHA Referee Schools. Much of the exodus can be attributed to a lack of development opportunities which are required for their skill development and their confidence to officiate at higher levels of minor hockey. This change will provide a path to certification through the retention of officials in the program. The four (4) consecutive years equates to officials who will be at a minimum of 20

years of age, and for those officials who entered the program at age 14, will have been officials for six (6) years. Personnel involved with the OMHA Referee Program are acutely aware that retention of officials is an ongoing concern.

Below is an excerpt from the Technical Director - Referees Podcast on 17 Dec. 2015

One of the biggest challenges we do have is retention at the younger levels. For various reasons, whether they go to school, whether they get a job, whether they move out of the community. We're trying to find ways to keep that retention up."

This will go a long way to begin the process of retaining officials and stem the tide of officials leaving/quitting the referee program.

Maintaining the status quo is no longer an acceptable path forward.

Currently Certification can only be achieved in Representative Games (contrary to the Manual of Operations and the OMHA HCOP Referee Policy), suggesting that if an Official is not yet accomplished in a Representative Game, they are "not good enough" to Referee in a House League/Local League Game. In reality, the best Officials are developed in House League/Local League Programming, providing each with the tools to advance to higher levels of hockey. This is one small step forward to retaining officials, and as one might expect, the longer they officiate, the better they get. This change/clarification will ensure that the Regulations and Policies are clear and will be followed.
