If the Boosters find such sale of items unsuitable, a representative shall make a verbal request that the attempted sale of such items stop. If the vendor does not stop, the vendor will be requested to leave by the local law enforcement.

The sale of items shall be overseen by the local law enforcement to assure compliance with the laws of the State of Maine and any restrictions imposed by SAD #6 and Bonny Eagle Football Boosters. This agreement must be signed and returned with your registration.
