Dear SCMAF S.G.V. Agency,

We would like to invite teams from your agency to participate in the 2023 SCMAF SGV "A", "B" and "C" Division Football Tournaments hosted by the City of Azusa's Recreation Division. This year's tournament will be held December 2<sup>nd</sup> and 3<sup>rd</sup> at Memorial Park in the City of Azusa. This is a single elimination tournament with a consolation bracket. Each team is guaranteed two games.

Enclosed you will find all the information necessary to enter your team(s) in this year's tournament. Tournament draws and directions to the park will be sent in advance of the tournament. Please make a note of the following dates and deadlines:

**All Entries are due: Wednesday, November 22nd, 2023 by 2:00 PM**

**COMPETITION WILL BE HELD IN THE FOLLOWING DIVISIONS:**

**Division (A):** Players born in 2010 or 2011

Players who are born in 2010 or 2011 and players born in 2009 and in a grade no higher than 8th are eligible. Players born in 2009 must provide written verification of grade. A player no older than 14 is eligible.

**Division (B):** Players born in 2012 or 2013

Players who are born in 2013 or 2013 and players born in 2011 and in a grade no higher than 6th are eligible. Players born in 2011 must provide written verification of grade. A player no older than 12 is eligible.

**Division (C):** Players born in 2014 or 2015

Players who are born in 2014 or 2015 and players born in 2013 and in a grade no higher than 4th are eligible. Players born in 2013 must provide written verification of grade. A player no older than 10 is eligible.

**Completed Registration Packets can be turned in 1 hour prior to your first game:**

- Team registration form (signed by Agency SCMAF Representative)
- Flag Football Official Roster
- Age verification (Copy of birth certificate or passport) for each player
- Proof of grade for any provisional player (signed letter from principal/registrar)
- SCMAF minor release form and consent for treatment form for each player

Eligibility:

1. All teams that participate must be promoted, organized, conducted and supervised by an agency that holds active membership in SCMAF San Gabriel Valley.
2. Use of an ineligible player will result in forfeit of team games. The Site Director will rule on any protests or questions of eligibility. **All participants will need proof of birth date and an unaltered SCMAF minor release form present at the tournament. Players that fall under the provisional rule for each division must provide written confirmation from the principal verifying school enrollment. Any player without these documents will be declared ineligible to participate in the tournament.**

Team Roster: Team rosters will be limited to sixteen players and three coaches. Rosters are due one (1) hour prior to your team's first game. SCMAF member **must** sign roster or team will not be allowed to compete.

## **TOURNAMENT RULES**

**With the exception of the following modifications, the SCMAF and National Federation Football rules shall govern play:**

1. Time, four (10)-minute quarters, running time, with regulation time last (2) minutes of the 2<sup>nd</sup> and 4th quarters. During running time, the clock shall be stopped by an official for a time out or after any score. After a time –out, the clock shall start on the next snap. After a score, the clock shall start on the kick-off.
2. There shall be one minute between quarters and five minutes between halves.
3. In the event one team is leading its opponent by (24) points or more, the “running time” clock will be used. The clock will only stop for charged time-outs and official time –outs. In addition, after any score, the trailing team will be awarded the ball on their own (35) yard line in lieu of a kickoff. Should the lead become less than a (24) point margin, the game will revert back to regulation timing and kickoffs.
4. Team bench will be limited to (16) uniformed players and three coaches.
5. Spectators must remain in the stands or designated spectator areas whenever seating facilities or designated spectator areas are available. If stands are not provided, spectators will keep at least (5) yards from the sidelines and end lines, and (5) yards from players benches.
6. Players must wear the same color jersey with numbers. At the time of play, all jerseys must be tucked into pants/shorts and terminate one inch above flag football belt line.
7. All equipment, such as game balls, timers, flags, etc will be provided by host agency and used for all games.
8. It is the coach's responsibility to get his/her line up to the scorekeeper prior to the start of the game.
9. Mouth Pieces are required for every participant. Staff and Officials will not allow a player to enter the game without a Mouth Piece
10. Shoes must be worn at all times; bare feet will not be permitted. **Screw in or metal cleats are illegal.** Use of molded rubber or multi –purpose shoes is recommended.
11. Time outs: four per game and one time out for every overtime period. (Note: only one time out per over time period may be used by each team.)
12. Personal protective equipment, such as knee guards, arm guards, etc. shall be inspected by officials prior to each game. NO regulation football equipment such as helmets, pads, etc. will be allowed. Shoes with metal, ceramic screw- in or detachable cleats are illegal.
13. **Minimum play rule will be enforced (free substitution once minimum play has been met in each half).** (Please see attached rule sheet for definition of minimum play rule).
14. Awards presentation will follow each championship game.

## **SCMAF Minimum Play Rule Specifics**

1. Each player must play a minimum of five (5) consecutive minutes which includes all offensive, defensive and kicking plays in each half.
2. Players must start their consecutive minutes at either the beginning or mid-point of a quarter.
3. Officials will call a time out, not charged to either team, at the mid-point of each quarter or the next dead ball, for the purpose of meeting the minimum play rule. Please note once the minimum play rule has been met by both teams, the officials will not call time out and free substitution will be allowed.
4. The official scorekeeper will determine compliance. Penalty for non-compliance will be forfeiture of the game.
5. Consecutive minutes must be played within one quarter of each half.
6. Consecutive minutes begun in one quarter may not be carried over into the next quarter or half.
7. Late arriving athletes, if time permits, must play the minimum consecutive minutes with the half of their arrival.
8. Injuries that keep the player from returning to the game are exceptions.
9. Tournament Director, with respect to satisfactorily meeting the requirement of the minimum play rule, will rule upon injuries that keep the player out of play for more than one play.
