WAIVER AND RELEASE OF LIABILITY
(For those participants UNDER 18 yrs of age)

*By signing this form you give up important legal rights.
Please read carefully!*

This is a binding legal agreement. I am the parent or legal guardian of the Participant (the “**Participant**”), who desires to participate in the programs, activities and events of Ontario Soccer, its Districts, Leagues and Clubs.

Executing this agreement will not preclude the Participant from accident insurance coverage, subject to the terms and conditions of Ontario Soccer’s accident insurance policy.

In consideration of the opportunity to participate in such programs, activities and events (playing soccer and/or participating in other soccer-related activities) hereinafter referred to as soccer, I, on behalf of the Participant, myself, the Participant’s parent(s) or guardian(s), heir(s), estate, insurers, assigns and anyone else who may make any claim for or on behalf of the Participant, acknowledge and agree to the following terms and hereby irrevocably and unconditionally:

1. represent and warrant that the Participant is in good health and physical condition, and acknowledge and understand that participation in soccer involves certain risks and dangers of accidents, serious personal and bodily injury, including death, and property loss or damage either specifically as a result of participation in soccer or generally in connection with attendance therein and transportation therefrom. I understand, have considered and evaluated the nature, scope, and extent of the risks involved, and I voluntarily and freely choose to allow the Participant to assume these risks;

2. understand that the above-noted risks and dangers, include but are not limited to injuries from:
 - Executing strenuous and demanding physical techniques in soccer;
 - Dryland training including weights, running, and massage;
 - Grass, turf and other surfaces including bacterial infections and rashes;
 - Falls to the ground due to uneven or irregular terrain or surfaces;

- Collisions with walls and soccer equipment;
 - Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment;
 - Spinal cord injuries which may render me permanently paralyzed;
 - Extreme weather conditions which may result in heatstroke, sunstroke or hypothermia;
 - Contact, colliding or being struck by other participants, spectators, equipment or vehicles;
 - Vigorous physical exertion and strenuous cardiovascular workouts;
 - Exerting and stretching various muscle groups;
 - Travel to and from competitive events and associated non-competitive events which are an integral part of the organization's activities.
 - That injuries sustained in soccer can be severe;
 - That the Participant may come into close contact with other participants, including the possibility of accidental and unexpected contact;
 - That the Participant may experience anxiety while challenging himself/herself during the activities;
 - That risk of injury is reduced if all rules adopted during training are followed; and
 - That risk of injury increases as the Participant becomes fatigued.
3. fully and forever release, discharge and indemnify Ontario Soccer, and each of its parent companies, affiliates, divisions, subsidiaries, directors, officers, employees, agents, insurers, assigns and successors, together with all soccer directors, volunteers, staff, coaches, training and medical personnel (collectively, the "**Released Parties**") of and from any and all causes of action, lawsuits, losses, damages, injuries, howsoever occurring, whether by negligence or otherwise, (including death) claims, demands, sums, costs, expenses (including legal fees and disbursements), and any other liability of any kind, of or to the Participant or any other person, directly or indirectly arising out of or in connection with participation in and attendance in soccer, including, without limitation, transportation related to soccer;
4. agree not to initiate any lawsuit, court action or other legal proceeding against the Released Parties, nor join or assist in the prosecution of any claim for money damages which anyone may have, on account of loss, damage, or injury sustained by the Participant or others, howsoever occurring, whether by negligence or otherwise, in connection with participation in and attendance in soccer, and I waive any right the Participant may have to do so. This means that the Participant cannot sue to hold the Released Parties responsible for any loss,

damage, or injury that he/she may experience related to soccer including, without limitation, transportation related to soccer;

5. waive the Participant's insurers' right to make a claim against the Released Parties based on insurance payments made to me or on my behalf for any reason. This means the Participant's insurers have no right of subrogation;
6. agree to hold harmless, indemnify and reimburse the Released Parties from and for any sums, costs, or expenses (including legal fees and disbursements) incurred or suffered by any of the Released Parties or paid by them to any person (including me or my insurers) in connection with any accident, loss, damage, injuries, howsoever occurring, whether by negligence or otherwise (including death), claims, demands, lawsuits, expenses and any other liability of any kind, sustained by the Participant or others in connection with his/her participation in soccer. This means that the Participant, the Participant's parent(s) or guardian(s), heir(s), estate, insurers, assigns and anyone else who may make any claim for or on behalf of the Participant will reimburse the Released Parties if anyone makes a claim against them based on damages or injuries the Participant suffers;
7. acknowledge that if any portion of this Acknowledgement, Release and Waiver is held to be invalid or unenforceable, all other provisions shall nevertheless continue to be valid and enforceable. This Acknowledgement, Release and Waiver supersedes any oral or written statements made by or to the Participant in connection with soccer. I understand that I, on behalf of the Participant, myself, the Participant's parent(s) or guardian(s), heir(s), estate, insurers, assigns and anyone else who may make any claim for or on behalf of the Participant, cannot terminate, cancel or revoke this Acknowledgement, Release and Waiver for any reason;
8. agree that, in the event that I cannot be reached in a medical emergency, unless otherwise indicated by me, I hereby authorize and permit the Released Parties and soccer personnel to administer first aid to the Participant and to authorize such other medical treatment and transportation as may be recommended by physicians, paramedics and other medical personnel, in the event of any illness, accident or injury to the Participant;
9. further agree that this document is governed by the laws of the Province of Ontario and operates to the benefit of the Released Parties as well as their administrators, successors and assigns, and is binding on me, the Participant,

the Participant's parent(s) or guardian(s), heir(s), estate, insurers, assigns and anyone else who may make any claim for or on behalf of the Participant.

I HAVE READ THIS ACKNOWLEDGEMENT, RELEASE AND WAIVER FORM CAREFULLY. I FULLY UNDERSTAND ITS CONTENT, AND VOLUNTARILY AGREE TO ITS TERMS. BY SIGNING THIS ACKNOWLEDGEMENT, RELEASE AND WAIVER, I UNDERSTAND THAT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.
