They will be separated by 7<sup>th</sup> & 8<sup>th</sup> grade. If players are needed for the team they will need to alternate floating a few kids between teams, as needed. Matt & Bill will coach both teams. Concussion testing must be completed on YCLA's website by parents. U-10 Boys: Board voted Keenan Beinhower will bump up to U-10. Nicholas Beck is showing on U-10 but should be listed on U-8.

U-8 Boys: They will be registered with YCLA and if there are not enough teams to play they will have to play up. For now we will keep them separated and find out how many U-8 teams will be registered in YCLA. If there are 3 or less teams we will bump the kids up to U-10. Mid Penn had 40 U-8 kids as an option for the kids to play against.
