**Approval of September Minutes:** Dan motioned to approve the September minutes. Todd seconded the motion. All were in favor.

### **President's Report: Ryan**

Ryan had placed a large order for supplies. Hockey Monkey cancelled the order so he will resubmit it.

### **Treasurer's Report: Troy**

Troy presented the treasurer's report. He compared the numbers from last year to this year. We have more income coming in due to Sponsorship money and increased tournament revenue.

### **Old Business**

#### **1. 10u Games/Planning**

Everybody is playing ½ ice 10u games this year. We need 15 minutes to set up and 15 minutes to remove the boards. We talked about donating them to the city so the city will be responsible for storage of them. The board is in favor of this idea so we don't have to store them. Alyssa will move ahead with scheduling ½ ice games for 10u. Ryan is going to communicate with Wenatchee to facilitate moving them back.

We also talked about possibly getting a 2nd set of full size nets. This would allow us to host a jamboree for 10u games or a tournament in the future. There was discussion about which net sizes are needed and upon checking, 10u should be playing with the intermediate sized nets.

#### **2. Tournament Updates**

Tournaments are all full. The last 18u team registered today. All tournaments will have 10 teams. We will begin at 3pm on Friday. The last games will start at 9pm. There was discussion on what teams will play the early game on Friday. Scott is working with the teams to figure out who can make those games.

#### **3. LTAC Grant**

Scott F. went to the meeting. Troy asked for money to cover new heaters, speakers, tournament fees and a few other things. Scott felt it went well. We are waiting to hear if and what money we will get.

Mike will order blue pucks and helmet beanies. The frames of the nets need some welding help. We could use a 2nd set of intermediate nets. Troy motioned to purchase a 2nd set of intermediate nets. Dan seconded. All were in favor of moving forward with this purchase. This will allow us to run a 10u and 8u game at the same time.

Mike made a video for the association. We'll push it out to Facebook and it will be played when the teams come out throughout the year.

## **6. Hockey Director**

This position must be appointed every year. Dan made a motion to appoint Mike Meetsma as Hockey Director for the 2025-2026. Troy seconded the motion. All were in favor.

## **7. Parks and Rec Hockey and Gear Handout**

Angelica Ward is going to be the Beginning Hockey Coordinator. Kelli will work with the city to get the roster and pass info to Angelica. We will set a time for gear handout at the next meeting.

## **8. Try Hockey for Free and Season Opener Party??**

If we have a date we can plan a season kick-off party, we would like to host this in conjunction with a Try Hockey For Free event. Kathleen Ranjan is willing to help plan it. We will find out from Alyssa if there is a date that will work and get Kathleen on planning it.

## **9. Custom license plates, key chains and hats**

We have a parent that has a family member who was willing to provide these services. Melanie is going to reach out and work with them. The board is ok with it if they use our logo and colors.

## **10. Electronic Scoring**

We talked about switching to TeamLinkt vs. staying with Game Sheets. We have heard some things about Team Linkt that aren't positive. Kelli will reach out to Game Sheets to check costs of using it outside of PNAHA.

## **11. Adult League Hockey Tournament**

There was discussion surrounding the Adult League's continued use of our tax benefits and organizations name on it's tournament documents. There were concerns raised for several reasons. Dan motioned that we cut ties with the adult hockey tournament. Troy seconded the motion. All were in favor. Ryan will let them know they need to put the paperwork together themselves and we aren't signing off on it.
