



PSVBA Flagship Facility Rules

Location

Our facility address is **4918 – 20th Street E, Suite B, Fife, WA 98424**. We are located behind the Foothills Furniture Store. Drive to the back of the building to find us.

Parking

You may park in any of the 40+ vacant parking stalls at the back of the building unless marked "No Parking". There are parking stalls along the traffic cones facing the dock doors and in the adjacent truck yard parking lot. Do not park in the alley or in non-designated areas along the building as this is a fire lane. Do NOT BLOCK the chain-link gated entrance to the adjacent trucking yard at any time! Vehicles that block or are parked in the truck yard entrance area may/will be damaged due to incoming semi-trucks! PSVBA & the Trucking Company will not be held liable for damage or loss of vehicles! We also have hundreds of parking stalls that are available during non-business hours at the front of our building. Do not park in any parking stalls directly in front of the "Foothills Furniture" store, but any other open spot at the front of the building is acceptable to park.

Team Check-in

The gym will open 1 hour before the 1st round of play (usually 8 am for a 9 am start). Teams should check-in together when all or most members of the team are present. Only persons listed on the official team roster will be allowed to check-in at that time. All coaches and players must be on the official roster for entry. ID verification will be required for all coaches and adults on the roster. Once teams have checked in, coaches and players will only be allowed to enter/exit the facility through the Gym Entry.

PSVBA will provide warm-up balls and carts for all teams during their designated warm-up time. No outside balls and/or carts will be allowed in our facility.

Spectators

PSVBA will not be limiting the number of spectators per team. However, there is limited seating provided around the courts for spectators. We require spectators to vacate the seating around the court after their match is over to offer seating to those spectators that have a team competing. Teams that are officiating do not count as competing on the court, and their spectators will be required to vacate the seating around the courts for those that are.

There is a ~~\$5~~ ^{\$10} gate fee for spectators to enter the gym. No charge for spectators ~~60~~ ⁶⁵ years old or older; or those 10 years old or younger. USAV members are free with proof of membership (must present paper or mobile membership card & matching ID) to enter the gym. Spectators will be allowed to enter the gym approximately 30 minutes before the first scheduled match.

Spectators will only be allowed to enter/exit the facility through the Gym Entry.



Facility Rules

DO NOT come to the Facility if you are sick or experiencing illness, flu or COVID symptoms.

NO GUM Chewing allowed in the Gym!
NO FOOD allowed in the Gym!
NO EATING or SNACKING allowed in the Gym!
NO SPORTS or ENERGY drinks allowed in the Gym!
NO COFFEE or SODA allowed in the Gym!

ONLY WATER bottles or personal refillable water bottles are allowed in the gym! Personal water bottles filled with anything other than water is not allowed. If discovered the team will be assessed a 13-point penalty at the beginning of their next game. There is no water fountain or water bottle refill station in the facility, however a water cooler will be provided to refill water bottles if needed.

All food and snacks must be consumed outside the facility in the courtyard or their parked car. If discovered that a player or spectator is consuming food or drink other than water within the facility, the team will be assessed a 13-point penalty at the beginning of their next game. Multiple infractions will result in a forfeited game and/or match.

Teams will be provided a designated team backpack drop area where the players may spend their downtime while in the facility. **Personal coolers are NOT allowed in the gym or bag drop area. No consuming of food/snacks or drinking of anything other than their personal refillable water bottles are allowed in the team areas.** If discovered, the team will be assessed a 13-point penalty at the beginning of their next game.

Teams will be allowed to set up a tent, chairs, and food table in the marked off courtyard area in the parking lot outside the facility but must clean up their area properly before leaving the facility at the end of the day. Warming devices such as propane gas heaters are allowed if properly supervised throughout the day. No BBQ or fire log pits are allowed.

No personal chairs are allowed in the gym. Limited seating will be provided for the spectators of teams that are competing.

No outside balls and carts allowed in our facility. PSVBA will provide game balls and warm-up balls for the teams competing.

No outside music sources (portable and/or small personal speakers) allowed in the gym.
