b. Bantam Level Class AA, A, B1, and B. Classes A, B1 and B may be subdivided into Bantam Level Class AA, A, B1, and B. Classes A, B1 and B may be subdivided into Gold, Silver, or Bronze pools as approved by the NDAHA Board of Directors at the NDAHA Winter meeting to maximize competitive balance.

Pee Wee Level Class AA, A, B1, and B. Classes A, B1 and B may be subdivided into Gold, Silver, or Bronze pools as approved by the NDAHA Board of Directors at the NDAHA Winter meeting to maximize competitive balance.

Girls High School, "14U A" "14U B", "12U A" and "12U B", each of which may be combined at the discretion of the Girls Section Director and Girls Governance Committee and approved by the NDAHA Board of Directors prior to the start of the NDAHA League season.
