• **COMMISSIONER**

- We did not get any teams that were really willing and able to make it work to move their dates to 12/7/25. So we're going to continue as best as we can with the November 30<sup>th</sup> date being our last date. I understand if teams have to forfeit of which is very sad, but if in the event your team does need to forfeit on that date, please let us know asap so that the UIC can be notified and to avoid any forfeit fees. Information related to the survey on bars of the week was forwarded to the coaches and I hope that this information has been shared with your team members, but more importantly has also been shared with your sponsors. A lot of the feedback was valuable on how the sponsors and their representatives for the teams can work together to make the bar of the week successful. Sadly, the Pride Parade was rained out this year but sounds like everyone had a good time regardless. An email was received from iPride today (10/21) and it's just their usual delegate dispatch. Couple of highlights from that – all registered players have received an invite to the iPride portal, if you haven't signed in yet, you are encouraged to do so. One thing that was stressed in the delegate dispatch email was that there will be a newsletter that will be going out to individual players monthly as well as what they send to the delegates. ### **Old Business:**

- Dave Mondt / Joey Markakis: Governing Document Amendment Proposal – Rules of Play: Section 9.7
  - Discussion and new proposed verbiage was discussed. Rules of Play Section 9.7 will be updated prior to start of Spring 2026 season to reflect that masks will be required by all pitchers in the league all divisions and that masks will be provided by the league for each field.

### **New Business:**

- Dave Mondt: Governing Document Amendment Proposal – Rules of Play:  
Section: 16.4
  - This is correcting a typo to remove 3.04 and change it to 3.4. This will be updated in the by-laws prior to start of the Spring 2026 Season.
- Dave Mondt: Governing Document Amendment Proposal – Rules of Play:  
Section: 3.5
  - **Current Verbiage:** The team at fault of the forfeiture is responsible for paying the total umpire fees to the league for the game being forfeited. In the case both teams forfeit, both teams will pay the total umpire fees to the league.
  - **Proposed Verbiage:** The team at fault of the forfeiture, if the executive board is not notified within 48 hours of the first game of the game day, is responsible for paying the total umpire fees to the league for the game being forfeited. In the case both teams forfeit without providing 48 hours notice to the executive board, both teams will pay the total umpire fees to the league. Games that are played to completion but result in a forfeit will not result in a forfeit fee for either team.
  - **Voting:** 11 votes, amendment passes, Governing Documents will be updated prior to start of Spring 2026 Season.
