RENTAL FEES:

ROOKIE CAMP/TERMITES: \$150 refundable deposit, which will be returned in full upon the complete return of the borrowed equipment. Deposit must be provided via personal check before equipment package is released to you. Rookie Camp and Termites gear must be returned after the final session of each Rookie Camp or Termites session unless alternative arrangements are confirmed by the EPHA Equipment Coordinators.

MITES/TRAVEL: \$50 rental fee plus \$150 refundable deposit, which will be returned upon the complete return of the borrowed equipment. Deposit must be made before equipment package is released to you. Skaters are only eligible for equipment rental during their first full season of hockey (MITES or TRAVEL).

— Before you return your gear, please make sure that the gear is complete, clean and the skates are sharpened.—

RENTAL PERIOD:

Unless other arrangements are made with the EPHA, all rented equipment must be returned in full and good condition by March 15th. If equipment is not returned by March 15th, you will automatically be charged an additional year's rental fee. If select pieces are missing from your gear, you will be charged a replacement fee equal to the cost of the missing piece(s). If you fail to return any gear, your full \$150 deposit will be kept.

If your player requires a size increase during the season, please make an appointment with an EPHA representative by emailing the contact listed on the equipment page of the website (under New to Hockey).

EPHA is not acting as a representative of any equipment manufacturer or retailer and does not possess and expertise or information (above and beyond that possessed by the average consumer of hockey gear) relative to the condition or fitness of any equipment it provides to Renter. EPHA encourages Renter to seek expert opinion as to the condition and fitness of the equipment provided by EPHA.

RENTAL AGREEMENT

This Rental Agreement ("Agreement") made and entered into on the date provided below, by and between the above-named Parent (hereinafter "Renter") and the Eden Prairie Hockey Association ("EPHA") (Renter and EPHA hereafter collectively referred to as the "Parties")

TERMS & CONDITIONS

EPHA agrees:

1// EPHA is the owner of hockey equipment (hereafter "Equipment") and wishes to allow Renter to temporarily use a complete or partial set of Equipment as noted herein. A complete set of Equipment consists of helmet, elbow pads, shoulder pads, gloves, pants, shin guards, equipment bag, skates and stick.

2// EPHA shall hold a security deposit from Renter for the duration of the term. The security deposit will be returned upon return of the Equipment, in good condition, free of excessive wear

3// To determine the condition of the Equipment, including whether excessive wear has occurred, in a good faith manner.

EPHA is not acting as a representative of any Equipment manufacturer or retailer and does not possess any expertise or information (above and beyond that possessed by the average consumer of hockey gear) relative to the condition or fitness of any Equipment it provides to Renter. EPHA encourages Renter to seek expert opinion as to the condition and fitness of the Equipment provided by EPHA.

Renter agrees:

1// To use Equipment for EPHA functions only. Players found using Equipment for street hockey or other functions not sanctioned by EPHA will be asked to immediately return the Equipment to EPHA.

2// To inspect the Equipment before accepting it and to notify EPHA, in a timely manner of any excessive wear or defect (e.g. stains, tears, rips, missing rivets, buckles, fasteners, etc.).

3// To care for the Equipment and keep it in good condition with the exception of reasonable wear and tear.

4// To allow EPHA, in its sole discretion, to determine whether the amount of wear on the Equipment is excessive.

5// To return the Equipment to EPHA at the end of the rental period in a clean and workable condition. Equipment return dates will be posted on EPHA's website and will be the responsibility of the parent/guardian to get dates from website and return Equipment on specified date. Deposit will be returned after all Equipment has been returned in proper condition to EPHA Equipment Director. Once the deposit is returned, no additional refund or credit will be made.

6// To pay a security deposit of \$_____ in the form of a cash, check, electronic transfer or credit card that will be held by EPHA until the Equipment is returned and a determination is made that the Equipment is in good condition.

7// To pay a rental fee of \$_____ for the rental period noted above.

8// To replace lost or damaged (other than normal wear and tear) Equipment to Eden Prairie Hockey Association and notify the Equipment Director of Equipment damages or lost Equipment. If Equipment is damaged or lost and not replaced EPHA will have the right to retain refundable deposit.

9// Renter understands that to participate in EPHA activities or participate on an EPHA sponsored hockey team, Renter must supply their child with additional equipment (e.g. jersey, hockey socks, garter belt, mouth guard, athletic protector skate guards and neck guard).

10// Renter is fully aware of the inherent risks and hazards connected with participation in the sport of ice hockey and is aware that such activities include the risk of injury and even death. Renter hereby elects to allow renter's child to voluntarily participate in said activities and to utilize the Equipment provided by EPHA knowing that the Equipment may not fully prevent injury to my child. I understand that EPHA does not require my child to participate in this activity and does not require my child to use the Equipment rented from EPHA. I voluntarily assume full responsibility for any personal injury, including death, that may be sustained by my child while utilizing the rented Equipment, to the fullest extent allowed by law.

11// Renter also fully understands and agrees that they have had an opportunity to obtain an expert opinion on the condition of the Equipment and whether or not the particular set of Equipment or the condition and fitness of such Equipment is appropriate to use for the purpose intended of protection while playing ice hockey. Renter, on behalf of his or herself and on behalf of Renter's child, hereby RELEASES, WAIVES, DISCHARGES, AND HOLD HARMLESS the EPHA, the Eden Prairie Hockey Board of Directors, and all their officers, agents, employees, staff, volunteers and insurers from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by Renter or Renter's child, or to any property belonging to Renter or Renter's child, while using the Equipment, REGARDLESS OF WHETHER SUCH LOSS IS CAUSED BY THE NEGLIGENCE OF THE EPHA, or otherwise and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, to the fullest extent allowed by law.

12// Renter further agrees to INDEMNIFY AND HOLD HARMLESS EPHA, the Eden Prairie Hockey Board of Directors, and all their officers, agents, employees, staff and volunteers from any loss, liability, damage, or costs, including court costs and attorneys' fees that Renter's child may incur while using Equipment, WHETHER CAUSED BY NEGLIGENCE OF the EPHA or otherwise, to the fullest extent allowed by law.
