



In consideration of being permitted to participate in skating, hockey and other ice related activities at the Ice Den Scottsdale/Ice Den Chandler, I hereby agree to the following:

ASSUMPTION OF RISK:

I understand and appreciate that: there are risks of serious personal injury in connection with participating in skating and ice hockey and voluntarily assume and accept those risks, including the risk of illness from exposure to COVID-19 and other viruses. I unconditionally release, waive and covenant not to sue Coyotes Ice, LLC ("Ice Den Scottsdale"), Coyotes Ice 2, LLC ("Ice Den Chandler") and any of their affiliates and subsidiaries, their promotional sponsors and advertisers, and their agents, servants and employees from any and all suits, claims and demands of any kind for personal injuries, property damage, including but not limited to lost, stolen or damaged goods, that I may sustain while participating in hockey, skating and all related activities at the Ice Den Scottsdale/Ice Den Chandler.

CONSENT TO TREAT:

I certify that, as parent or guardian of said participant, I give my consent to Ice Den Scottsdale/Ice Den Chandler and staff to obtain medical care from any licensed physician, hospital, or clinic for said participant, for any injury that could arise from participation in any activities at Ice Den Scottsdale/Ice Den Chandler.

CONSENT TO USE OF IMAGE:

I hereby give my consent to Coyotes Ice, LLC and Coyotes Ice 2, LLC to use my image/likeness for the purpose of inclusion in any publications/videos related to Ice Den Scottsdale or Ice Den Chandler.

REFUND POLICY:

No refunds will be given to a registrant who leaves because of their own desire, fails to attend or is suspended from League participation for any reason. The ONLY exception where a refund will be approved is in the event of injury or illness that is accompanied by written confirmation of a doctor that verifies a medical condition excusing the player from participation in the program. This must be submitted within 30 days of illness/injury. Refunds will not be awarded for games missed due to illness including but not limited to COVID-19 related illness, exposure, or level of comfort. Please note, there will be a \$20 administrative fee assessed to any refunds.

ARIZONA STATE LAW/ICE DEN ALCOHOL POLICY ACCEPTANCE:

I understand that the only area of either the Ice Den Scottsdale or the Ice Den Chandler where the service or consumption of alcohol is allowed is within the boundaries of the two restaurants, 18° Bar & Grill in Scottsdale or 18° Express in Chandler. I further understand that the bringing, service or consumption of alcohol in any other area of either facility or anywhere around the exterior of the facility is against Arizona State law and is strictly prohibited and that any violation of this policy may result in the Ice Den expressing its right to revoke participation and registration privileges for any future Ice Den programs conducted at the Ice Den Scottsdale or Ice Den Chandler as the result of unacceptable player conduct.

Alcohol is not permitted in rinks or locker rooms at any time. Tailgating is not permitted on Ice Den property.

RESPECT THE RINK:

The Ice Dens are proud to be home to the CAHL. The staff works hard to ensure the facility, ice surfaces and amenities operate effectively and efficiently. In return, we ask that all community members treat the Ice Den employees, facilities and amenities with respect and care. By following posted rules, adhering to building policies and staff instruction, together we can work to ensure a fun, safe and professional experience for all.

Please Be Advised: Damage caused by unacceptable behavior, including but not limited to: shooting pucks off-ice/outside at building exterior, climbing on pads, breaking equipment, vandalizing locker rooms or any areas within the facility, its amenities and surrounding properties, will be investigated and invoiced to the responsible individuals.
