**PURPOSE:**

To set the guidelines for Coaching Staff, Team and Spectator Seating during games governed by LCSC

**POLICY:**

It is the policy of Logan County Soccer Club that teams at LCSC governed games will be seated facing east toward academy road, the spectator's seating will face west toward the trees, except for the U6 and U8 fields. The U6 teams will be seated in between the U6 fields and the spectator's seating for the U6 fields will be on the north and south side of both of the U6 fields combined. The U8 teams will be seated in between the U8 fields and the spectator's seating for the U8 fields will be on the north and south side of both of the U8 fields combined.

Coaching Staff allowed on the sideline with each team is whomever is listed on the official roster. Excess Coaching Staff, Team Representatives and spectators will be asked to move to the spectator seating area as outlined in this policy.

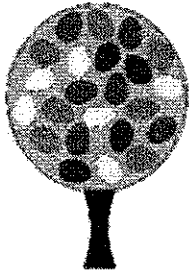
**PROCEDURE:**

1. Spectators – All spectators will seat themselves in the stands, or in seating they provide (lawn chairs, etc). Spectator seating must be at least 2 yards from the touchline. Spectator seating will be on the east side of the field so that the spectator's are facing west toward the trees, except for the U6 and U8 fields. Spectator seating will be on the north and south side of both of the U6 and U8 fields combined
  - a. Definition of Spectator – Any person that is not a player or individual listed on the official roster is considered a spectator

2. Teams – All teams participating in a game governed by LCSC will seat themselves on the west side of the field facing east toward Academy road, except for the U6 and U8 fields. Team seating for U6 & U8 will be in between the two fields.
  - a. Definition of a Team – a group of LCSC registered players that have been assigned to the roster of a particular coach for LCSC
  
3. Coaching Staff – All Coaches and their designated Assistant Coach will seat themselves with their respective team only if they are listed on the official roster.
  - a. Definition of Coach – The Coach is the person registered with LCSC (or visiting Club team) as being the coach of one of the teams playing the match and is listed on the official roster.
  - b. Definition of Assistant Coach – the Assistant Coach is designated by the Coach of the team playing the match and is listed on the official roster
  
4. At no time during the game governed by LCSC shall the spectators seat themselves with the teams or at the ends of the field near the goals. The Coach, Assistant Coach, Referee and/or LCSC Board of Directors will ask them to move. If they do not move then the match will be suspended.

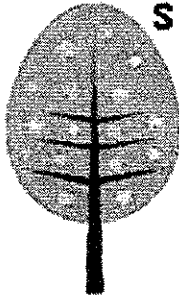

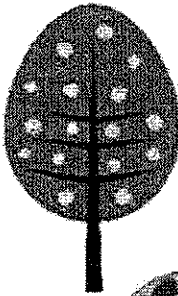

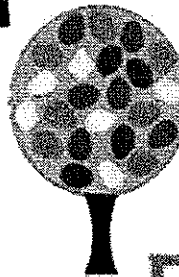
