2. Approve Minutes: L.Doko

3. Treasurer Report: N. Gray

- Bank Balance on June 9th, 2025: \$13,172
- \$4,655 due in True-Up bills
- Just under \$18,000 expected at 2025 season-end balance.
- Commissioner Adam Marfice shared that the new set amount process of billing each program \$3,000 at the beginning of the season was an accurate amount set, with some programs within plus/minus \$150. The straight billing approach simplified and streamlined the beginning of the season vs previous years using actual rosters at the start of the season.

4. Finalize 2025 Awards: G. Hein

- USA Lacrosse Awards have been submitted and pending approval. There is a strict embargo until official approval is received. It is expected before July 1, 2025. Once the approval is received, the IHSL membership will be notified via email and awards will also be shared on IHSL social media platforms.

5. Season Wrap & Feedback: A. Marfice

- The vast majority of feedback was favorable. Opportunity to align East and North regionals. Results will be shared with the membership.
- Game changes remained a labor intensive process for the 2025 season, resulting in 65 game changes, with various lead times. It is recommended to the new Board to consider additional role(s) to assist with this area of the league, and ways to better manage, while programs are asked to take steps to minimize game change submissions.

6. Board Recruitment and Elections: A. Marfice

- As of June 9, 2025:
 - One candidate for Commissioner: Chris Hill, Spokane Valley
 - Zero candidates for Secretary
 - One candidate for Treasurer: Incumbent Natalie Gray
