Frequently Asked Questions:

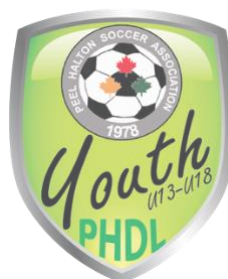
- ⚽ League Hearing Nights
 - League hearings will be scheduled Mondays-Fridays

- ⚽ Request for Hearing:
 - Except in cases of misconduct Type 1.3, 1.5, and 1.6, an individual who is subject to the DBR (Discipline by Review) system shall have the right to request to be disciplined by the DBH (Discipline by Hearing) system. The accused must submit a written request to the league within four (4) days of receiving the dismissal. The written request must be received within the stipulated time along with the required fee. Please refer to Appendix A – Schedule of Fines, Fees and Penalties

- ⚽ Request for Postponement:
 - Any party required to attend a hearing may request one (1) postponement. The party must submit a written request no later than four (4) days prior to the date of the hearing. The written request must be received within the stipulated time along with the required fee. Please refer to Appendix A – Schedule of Fines, Fees and Penalties

- ⚽ Standard Penalties for Misconduct:
 - Suspensions and Fines will be in accordance with the Standard Penalties for Misconduct Table provided in the Ontario Soccer Discipline Policies and Procedures under Procedure 9.0

Appendix A – Schedule of Fines, Fees and Penalties

LEAGUE FEES	Amount
Team Registration Fee	\$500
Late Registration Fee	Additional \$75
Late Registration (after March 1 st)	Additional \$150
Team withdrawal (before April 1 st)	Loss of entry fee
Team withdrawal (starting April 1 st)	Loss of entry fee plus a \$500 fine
Team withdrawal (starting May 1st)	Loss of entry fee & a \$1500 fine
HEARING FEES	Amount
Discipline by Hearing Request from DBR (refunded if found not guilty)	\$125
Discipline by Hearing (Admin charges) – Club/Academy/T.O./Player	\$100 / \$100 / \$25
Discipline by Review (Admin charges) – Club/Academy/T.O./Player	\$75 / \$75 / \$25
Request to reschedule a Hearing - payable as per Rules	\$250
File a Protest	\$300
Protest denied	Entire fee retained
Protest granted	Fee refunded less \$150 admin fee
FINES	Amount
Club/Academy/Team failing to comply with YPHDL Rules	\$250
Team failing to provide / comply with Team Responsibilities - Section 7	1 st \$125 / 2 nd \$250 / 3 rd & subsequent \$400
Failure to comply with Home Club/Academy Responsibilities - Section 7	\$150
Game Sheet violations - Section 14	\$50
Club/Academy/Team playing an ineligible player	\$300
Game abandonment	\$300
Failure to appear by Club/Academy at a hearing where required to attend	\$300

Fines Fees and Payments

- All payments must be credit card, cash, Club/Academy cheque or money order, payable to the PHSA within 28 days
- All hearing fees and fines for DBR & DBH for players will automatically be billed to the Club/Academy
- Club/Academys are responsible for all fees and fines of team officials and players
- Club/Academys who fail to submit payment for discipline hearing fees or fines within the stipulated time will be declared not in good standing and their District Association and **OS** will be notified
