Collections and Registration Policies

Club Registration and Collections

A player will NOT be registered until their fees have been paid and therefore not eligible to play or train.

Payment plans are available for those that require them and should be immediately brought to the Administrators attention so that an arrangement can be discussed privately prior to the required payment date. We are here to work with you.

For players on a recurring payment model, should they discontinue or fail to complete payments, they will be contacted by a Club official. Failure to communicate with the Club to find a solution and ensure that all fees are paid in a timely manner will result in their removal from program access.

Club Registrations

- only once a player registers with NFSC Inc. will they be registered as an official player with our governing body.
- Registration validity for a player can take up to 24 hours to take effect within the registration system.
- Registration for any NFSC – NIAGARA FC Competitive and Development teams must be paid by November 30th unless a payment arrangement has been made.
- Those who do not pay by the November 30th deadline will be subject to a \$30.00 late fee. (For TITANS Team registration only)
- NFSC typically opens registration for the Outdoor House League program in early January every year and continues until opening day and beyond.
- We have a "Turn no Child Away" policy which states that if we have a spot available for a child/uniform we will provide them with an appropriate place to play.
- NFSC offers a \$20.00 multi child discount within recreational and/or developmental soccer programs. Those who qualify should contact our Administrator.
- NFSC may have waitlists for some of our programs. We recommended that participants register early (January-April) to avoid this potentially occurring.

NFSC can at times exchange programs for a credit, if they deem it to have no impact on the team they are on and have good merit, such as a long-term injury, or changing programs that are a better fit for the participant. If this scenario occurs, you should contact the Office.

Collections and Registration Policies

Player Releases/Transfers

NFSC TITANS competitive or development players will not be released or transferred until ALL outstanding club fees & team fees have been paid in full.

NIAGARA FC OPDL Players may be placed in bad standing if full payment has not been made on the time schedule allotted, or arranged upon. Any arranged outstanding fees must be paid up no later than August 1st of that season.

A player will **NOT** be registered for their respective league if outstanding fines or fees have not been paid.

Although cheques are not an accepted form of payment for our Club programs, returned cheques which may be accepted for Tournaments/Festivals are subject to a \$30 NSF admin fee.

Fines - Players, Coaches, Teams

Fines incurred by a player, coach or team must be paid to NFSC within 10 days of the fine being issued. NFSC will not be responsible for payment of fines, received by players, coaches and teams.
