 - ii. Printer every door direct mailer requires a special postal mark. Hope to have this out on 8/24... delay at printer. Nick to ask about a discount as this is later than what we were quoted.
 - h. Equipment fitting
 - New hockey players will have fitting at Scheel's on 9/12 and 10/6;
 trying to get as many to first one.
- 6. Capital improvement update
 - a. Updates on pursuing new rinkNick Davidson
 - i. CJ and Nick working on this have identified city owned land near Kwik Trip. Have met with city administrator and a possible developer (EDA).
 - ii. Will need discussions on rink management
 - iii. Will identify strategy to do this without impacting taxes
 - iv. Ken Wilcox also willing to help— has prior experience with this
- 7. DIBS— no new updates. May be need to upload DIBS for equipment fitting

- a. Will need to look at impact of COVID we may not be able to open. Most rinks have had concessions closed this summer.

- b. MN Hockey guidelines are still tentative; developing a back-up plan
 - i. May start early and go longer to allow for cancellations
 - ii. Recommendations for a COVID director for all organizations
 - iii. Cost to reschedule games still not clear
 - iv. Possibly change number of games and tournaments
 - 1. Bantams 40 games, 3 tournaments max
 - 2. Peewees/12 30 games max
 - 3. Squirt/10 20 games max
 - 4. Out of state tournaments no longer offering protection- it is a "buyer beware" situation
 - 5. *All tournaments so far do have some sort of COVID clause.
 - v. Voted against "Parent Police" for teams; this was voted down quickly
 - vi. Girls program need to get numbers in ASAP
 - vii. Officials and coaching will be virtual this year
 - viii. D9 checking clinic at our arena we don't have guidance yet still tentative on
 - ix. Possibly changing some rules more to come (i.e., no checking Bantam C; shorter penalty times at levels)
- c. Need motion starting season 2 weeks early and extending 2 weeks; may be difficult to start early as ice times are scheduled, but could possibly go late
