GEAR RENTAL AGREEMENT



Rental gear is being requested for use by the youth player ("Participant") currently being registered. As the parent(s)/guardian(s) ("Renter") requesting rental gear from the Palouse Youth Hockey Association ("PYHA"), it is understood that the rental period is the same time frame as that of the 2021-2022 PYHA hockey season ("Season").

The complete set of rental gear ("Gear") consists of the following protective equipment: helmet, chest pad, pair of elbow pads, pair of gloves, pants, pair of shin guards, and an equipment bag. Skates and sticks may be provided based on the availability of properly sized equipment. The cost to rent Gear from PYHA for the Season is \$40.28 (tax included).

By paying for and accepting Gear, Renter understands and agrees as follows:

- 1. That Renter will inspect Gear before accepting it and notify PYHA, in a timely manner, of any excessive wear or defect (including, but not limited to stains, tears, rips, and missing rivets, buckles, or fasteners);
- 2. That Gear is sized for and should be worn only by Participant;
- 3. That Gear will be used only for participation in ice hockey or related on-ice activity, or as otherwise deemed appropriate by Participant's coach (es);
- 4. That Renter will hold PYHA and its successors and assigns harmless and free of liability for any personal injury or property damage sustained by Participant while using Gear;
- 5. That Gear will be maintained in good condition, except for reasonable wear and tear;
- 6. That Gear is to be returned to PYHA at the end of the Season in clean and workable condition;
- 7. That Renter will pay replacement costs for Gear, or any portion of Gear not returned at the end of the Season.

Replacement cost is as follows:

Helmet \$25.00	Elbow Pads \$10.00	Chest Protector \$15.00	Gloves \$10.00
Breezers \$15.00	Shin Guards \$10.00	Skates \$25.00	Stick \$25.00

Providing rental Gear is an additional service that PYHA offers in an effort to assist families who do not wish to purchase Gear at this time. Upon return of Gear by Renter at the end of the Season, PYHA will, in a good-faith manner, determine the condition of Gear, including whether or not excessive wear has occurred.

PYHA encourages Renter to seek expert opinions as the condition and fitness of the hockey equipment included in the above-stated set of Gear. PYHA denies responsibility for any injury that might occur to Participant while using the Gear, whether the equipment is worn correctly or incorrectly. Renter understands that participation in ice hockey, like other team sports and ice sports, is an inherently risky and potentially dangerous activity and that using the equipment rented from PYHA does not guarantee protection from bodily injury or property damage. Renter accepts responsibility for Participant's safety and his/her proper use of the equipment obtained from PYHA, and Renter agrees to seek any

professional advice or assistance necessary to minimize the risk to Participant, at Renter's option and expense.

Renter understands that to participate in PYHA activities or as part of a PYHA hockey team, Participant will require equipment in addition to the Gear-including, but not limited to ice hockey skates, hockey stick, hockey jersey, hockey socks, mouth guard, garter belt or jock/jane, cup/pelvic protector, and neck guard. PYHA provides a hockey socks and a neck guard to each new player, and for Mites provides a loaner jersey for use during the season; hockey sticks are available for loan on a first-come, first-served basis.PYHA is not acting as a representative of any hockey equipment manufacturer or retailer and does not claim to possess any expertise or information (above and beyond that possessed by the average consumer of hockey gear) relative to the condition or fitness of any gear it offers for rent.
