Season Fundraiser

- It costs us a minimum of \$50,000 to cover the costs of a XC season at the level of competition we provide to athletes.
- This requires that we have 100% participation in fair shares of \$300 per athlete and then we still need to fundraise to cover the \$30,000 we need above and beyond the amount covered by fair shares.
- This year we have only received 77% of the fair shares, so we need to raise even more than \$30,000 to cover all costs for the season.
- **We need to raise at least \$500 per athlete (at least \$30,000) AND we need those who haven't paid their fair shares to do so immediately.**
- If parents would rather do a direct donation instead of helping with fundraising, just reach out to me.
- As of today, we have raised a total of \$13,108. We have 9 days left. The girls team has raised just under \$4,000 and the boys are at about \$9,000. We still only have 18 girls signed up and 33 boys signed up.
