Key details of this status are the following:

- We need to stay distanced with **No contact** (at least 6 ft)
- Modules contain no **more than 12 people** in attendance (including coaching staff)
- A coach/trainer per module and modules should not intermingle during a training session.
- **Bags should be 6 feet apart** and separate player gear into the modules you are training in.
- **NO** spectators are permitted during this time (contact us for medical or special requests)
- Parents can wait in their car or run errands.
- **NO** contact games or drills (Players touching)
- Masks upon entry and exit are **REQUIRED!**
- Temperature scans upon entry
- Gold Cal will provide sanitized balls for every module
- Courts are limited to 12 people, with one coach
- Encouragement of washing of hands before and after activity
- Transition time between rentals
- **NO** sharing of water bottles
- Restricting bathroom access to smaller numbers

RELEASE & INDEMNITY
