### **Old Business**

Approval of June Minutes – APPROVED

Treasurer Report – Nothing new. Intuit is going up to \$130 from \$114. OBYSA \$99 to \$115. 18 scholarships total have been given out totaling \$5400. 11 last fall, \$1000 over budget. Discussed difference in NPL pricing vs. TASL. NPL is \$1075 while TASL fees are \$640 (\$435 difference). Talk of raising fees in future if more teams plan to move to NPL.

### **New Business**
