## **ABOUT THE BOARD OF DIRECTORS**

The Summerlin South Little League Board of Directors is responsible for the operations of Summerlin South Little League. Directors are expected to actively attend meetings, and help operate the League on the day-to-day basis.

Under the League's Constitution, the members determine how many Directors to elect for the coming year (the minimum number permitted under the Constitution is six). After the Board of Directors is elected, the Board meets to elect its own officers. The term of office for the President, Vice President(s), Treasurer, Secretary, Player Agents(s) and Safety Officer is two years. The President, Secretary, Second Vice President, and Safety Officer are elected in even years and assume the role of that office on October 1st of that even year until September 30th of the following even year. The First Vice President, Treasurer, and Player Agents(s) are elected in odd years and assume the role of that office on October 1st of that odd year until September 30th of the following odd year.

In addition to these positions, the Board elects an Information Officer and Coaching Coordinator. Other Board members are appointed to have responsibility over equipment, fields and grounds, the snack shack, or other league operations.

If any of these officers are unable to complete their term of office due to death, resignation, election to another officer position or removal by the Board of Directors in accordance with Article VI, Section 5, then the replacement officer is elected by the Board of Directors and assumes the duties of that office for the remainder of the previous officer's term.

## **ABOUT MEMBERSHIP IN SUMMERLIN SOUTH LITTLE LEAGUE**

Any adult person actively interested in furthering the objectives of the League may become a Regular Member upon payment of \$1 dues at the Annual Meeting. Only Members in good standing are eligible to vote at General Membership Meetings. All Officers and Board Members must be Regular Members in good standing.
