General Update – Chris Johnson

- Introduction of any guests

Fields Update – Brad Kaplan

- Field Clean-up Date
 - Tentatively scheduled for October 12TH or 13TH
- Construction Update
 - All activities are expected to be completed by September 1ST.
- Shed Maintenance
 - Clean-up and organization have been done.
 - Do not allow kids to drive the tractor. They were seen during practice "hot dogging" on the field. This is completely unacceptable
 - The shed must be closed during games. Multiple times young children were seen going in and out of the shed during games.

• Lock Combination Changes

- All lock combinations where changed because too many non-coaches and players knew the codes. Kids have been seen playing on the field during the daytime and cages and gates have been left open multiple times. A chain was added to the batting cages because they were forced open.
- Locks will be changed again at the end of the fall baseball season and the codes will not be distributed until next season.

- I'll be registering all four teams tonight with Gopher State. A few kids haven't paid yet (because they
 were late sign ups. I still need to figure out and send them a link. I approved one scholarship upon
 request.
- As you know we refunded about 5 players at 15U and 16U who had paid because we didn't have enough boys at that age. Maybe next year.
- One last item. I paid \$30 to boost the Facebook post. (The same as in the spring). I will track down those receipts and hope to get reimbursed for the full \$60 if that's OK. The Fall Ball ads ran from July 21 to July 31 and had 2,528 impressions and generated 60 clicks.
