



Athlete/Staff Requirements, Additional Terms, the Assumption of the Risk, and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

The health and well-being of our staff and athletes remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow staff assigned to work, athletes scheduled to participate, and two parents per player to be in our court area. Parents wishing to remain on site must consent to a temperature check prior to entry, obtain one of two guest wristbands from player, and verbally answer our posted Covid-19 questionnaire. Any positive responses will be asked to leave. Parents may bring chairs to sit on sidelines and must wear a mask at all times.

Furthermore, all participants in sponsored activities at Williamsburg Volleyball Club must agree to and abide by the following: ● Wear face covering to/from the venue/courts ● Consent to temperature check prior to entry ● Use sanitization stations prior to each match ● **Refrain from any close** contact such as handshakes, high fives, and related celebration activities ● Follow all guidance of coaching staff, as well as posted guidelines ● Practice safe social distancing ● Refrain from participating if experiencing any symptoms ● Inform WVC of any positive COVID-19 virus test of player or anyone in the player's household

Williamsburg Volleyball Club (hereafter referred to as the "WVC") has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in WVC's gym/park environment; however, WVC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending sponsored activities at WVC could increase your risk and your child(ren)'s risk of contracting COVID-19.

WVC has scheduled two rain dates. If those dates cannot be used due to additional weather delays or are not sufficient, I understand that the Grass League will proceed without making up the missed dates and the record will stand as played. Additionally, I understand if the Grass League is shut down due to a COVID-19 outbreak, all fees will be non-refundable.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending WVC activities, and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at WVC may result from the actions, omissions, or negligence of myself and others, including, but not limited to, WVC employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at WVC or participation in WVC programming ("Claims").



On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless WVC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of WVC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any WVC activity.
