

## SAN JOSE JR. SHARKS GIRLS PLAYER AND FINANCIAL AGREEMENT

This Agreement is by and between the Player, the Player's parent or legal guardian if the Participant is under the age of eighteen (18) years or otherwise lacks legal capacity (collectively, the "Participant(s)"), and the San Jose Jr. Sharks Hockey Club (the "Jr. Sharks"), a program of SAN JOSE ARENA MANAGEMENT, LLC ("SJAM"). In consideration for the opportunity to participate in the activities associated with the **SAN JOSE JR. SHARKS HOCKEY CLUB** (the "Activities"), the Participant warrants and represents to the Jr. Sharks, SJAM, the City of San Jose, and their respective parents, affiliates, members, directors, officers, employees, agents and all others acting with the SJAM authority (collectively, the "Releasees") and hereby agrees the following:

**WAIVER AND RELEASE AGREEMENT.** Each Participant acknowledges that he/she has agreed to abide by the Jr. Sharks Rules and Policies; the Sharks Ice Code of Conduct; and any other rules, regulations and policies of the various hockey organizations with which the Jr. Sharks are affiliated (collectively, the "Rules") at all times. In addition, The Participants entered into a Waiver and Release Agreement with the Releasees prior to participating in the Jr. Sharks Tryouts, and the Participants acknowledge and understand that the terms and conditions of the Waiver and Release Agreement will continue in full force and effect through the conclusion of the **2018-19 Jr. Sharks Season**. All rules and policies can be found on the Jr. Sharks Website.

**FINANCIAL COMMITMENT.** The Participants understand that registration with the Jr. Sharks represents a full-season commitment. The Participants agree that the Player will not voluntarily seek to transfer to another team, league, affiliate and/or district during the Season without the Jr. Sharks' prior written approval and release from this Player Agreement and any remaining financial obligations for the Season, as determined in the Jr. Sharks' sole discretion. If the Participants choose to terminate this Agreement and/or the Player's relationship with the Jr. Sharks for any reason, or if the Player is suspended or dismissed from the Team for violation of the Rules, the Participants understand that they will not be entitled to any reimbursement of the Player Fee, and any reimbursement the Participants may receive will be determined in the sole discretion of the Jr. Sharks.

**FEES.** The Participants are responsible for full payment of the Jr. Sharks Dues and other Additional Expenses associated with participation in the Activities. The Jr. Sharks Dues include the cost of staff expenses, registration fees, coaches' fees, coaches' travel, tournament fees, league fees, practice ice fees, and other Jr. Sharks operational expenses. Additional Expenses, including but not limited to Player Travel and Soft Goods Expenses, are additional expenses above and beyond the Jr. Sharks Dues and must be paid separately by the Participants. Player siblings participating with the Jr. Sharks in the same Season are eligible for a ten percent (10%) discount applied to the lesser of the Jr. Sharks Dues owed.

**BILLING AND PAYMENT.** Billing and payment for the Activities will be completed through the Sharks online registration system at the Jr. Sharks website ([www.sjrsharks.com](http://www.sjrsharks.com)). The Participants agree to create an account and submit payment information through the online registration system by Wednesday June 6th, 2018. If agreement is given after June 6th participants will have 48 hours to complete online payment.

In addition to creating the online account, please complete the payment information on the following page for our records. Participants may pay Jr. Sharks Dues in one (1) payment, due by **June 6th, 2018**, or in six (6) monthly payments, with the first payment being due **June 6th, 2018**. Subsequent monthly payments will be due by the fifteen (15<sup>th</sup>) day of each month from July–December 2017. Participants who choose to pay through the **monthly payment plan will be charged a one-time administration fee of \$50.00** upon creation of their registration account. Participants paying by check or cash must contact Tyler Shaffar and/or make payment upon submission of this Agreement. Jr. Sharks Dues are **nonrefundable** and will not be adjusted due to injury, attendance, participation or any other factor.

Participants paying by check or cash must contact Tyler Shaffar and/or make payment upon submission of this Agreement. Jr. Sharks Dues are **nonrefundable** and will not be adjusted due to injury, attendance, participation or any other factor.

If Participants fail to create an account through the online registration system by **June 6th, 2018**, the Jr. Sharks may charge the Jr. Sharks Dues in full to the following account. In addition, if the Participants fall more than fifteen (15) days behind the due date of the Jr. Sharks Dues at anytime during the Season, upon notice to the Participants, the Jr. Sharks may charge up to the full amount of the remaining unpaid portion of the Jr. Sharks Dues to the following account. Participants with delinquent amounts 15 days or more past due may be suspended from all Jr. Sharks activities, including postseason play, until the account is made current. If a Player's account remains delinquent at the end of the Season, information related to the delinquency, including the status of the Player's sibling accounts, if any, will be reported to the governing league(s) and organizations, as applicable, and the Player and Player siblings may be declared ineligible to compete in USA Hockey activities per USA Hockey policies.

**SUPPORT HOURS.** The Participants understand that each Player family must fulfill ten (10) hours of Team Support ("DIBS") per Player as outlined in the Jr. Sharks Rules and Policies. Failure to participate in DIBS will result in a \$25 charge for each unfulfilled hour (up to \$250 per Player per Season). The Participants will be automatically added to the DIBS account through the Jr. Sharks website at the time the Participant creates an online registration account as detailed above.
