



HOTBAMA SANITATION POLICY – SUMMER 2020

This Policy applies to all HotBama teams playing Summer 2020, and is in addition to all other policies, requirements, guidelines, and restrictions of state and local authorities and host parks. HotBama makes no representations regarding, and bears no responsibility for, the safety of any person at any Summer 2020 event.

1. **General.** No player, coach, parent, guardian, or other family member may attend a team event while having any flu or corona-like symptoms, including without limitation: (i) fever, (ii) cough, (iii) congestion, (iv) aches, (v) shortness of breath, (vi) loss of taste/smell and/or (vii) upset stomach. It is the responsibility of each player and his family to ensure compliance with this requirement.
2. **Individual Parent/Player Responsibility.** Each player shall be responsible for (i) sanitizing his/her own equipment before and after each event (ii) hand sanitizing before and after practice and (iii) providing his/her own water bottle (labeled by name), which may not be shared with other team members. Equipment bags must be spread out by a minimum of 6 feet from each other on the sideline/bench area.

There will be no high-fiving or congregating of the team(s) at the beginning or end of practice. Parents should remain 6 feet away from other players, coaches, and other parents the entirety of practice. Use of shared water coolers is prohibited.

3. **Designation of Team Representative.** Each team shall designate a Team Representative responsible for administering and monitoring that team's compliance with this Policy. The Team Representative should be a parent or guardian of a player on that team.
4. **Ultimate Responsibility.** It is the responsibility of each player, parent, guardian, family member, or other guest/attendee to ensure his or her own safety. HotBama and the host parks have no responsibility for, and make no representations, warranties, or guaranties with respect to, anyone's safety.

WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration for participation in activities of HotBama and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS HotBama, their coaches, officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (“RELEASEES”), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
