How Players are Classified

Wheelchair rugby uses a classification system to ensure a fair and balanced competition. Each athlete is assigned a point value from 0.5 (greater physical impairment) to 3.5 (lesser impairment) based on their functional abilities, including trunk stability, arm and hand function, and balance. During play, the four athletes on the court may not exceed a combined total of 8.0 classification points, requiring teams to use strategy, chemistry, and teamwork, not just strength or speed to succeed. This system allows athletes with a wide range of abilities to compete together at the highest level while ensuring a sense of inclusion.
