PAYMENT METHODS: Cash, check, Venmo or Paypal

****All families must make their initial payment of \$1000 at signing by cash, check, venmo, or @HPquang or paypal WWW.Paypal.me/MVAMN. Write checks to “Minnesota Volleyball Academy” or “MVA”.**

<input type="checkbox"/>	#1 Cash –Select option 1, 2, or 3 above. For option 3 - We will pay \$1000 down payment at signing. For the season fee balance of 4 to 6 payments of the season fee, we will submit cash in an envelope written with player’s name, amount of payment for the month due, and before or by the 1st of the month from January to April or May (depending on team’s monthly payment option above) and hand deliver to Quang (please make prior arrangements).
<input type="checkbox"/>	#2 Check – Select option 1, 2 or 3 above. For option 3 -We will write a check for the down payment at signing for \$1000 to MVA. For the season fee balance, we will submit pre dated checks for the 1st of each month (Dec., Jan., Feb., Mar., April, and May) as detailed in the 2025-2026 Club Season Fees.
<input type="checkbox"/>	#3 Venmo or Paypal – Select option 1, 2 or 3 above. We will venmo \$1000 (please add venmo transaction fee) to @HPquang or paypal at WWW.Paypal.me/MVAMN at signing. For option 3 - For the season fee balance of 4 to 6 payments, we will submit payment via Venmo or Paypal for the amount of payment for the month due, and before or by the 1st of the month from January to April or May (depending on team’s monthly payment options selected).
