## 1 COMPETITION NAME AND DIVISIONS

---

1.1 The name of the competition shall be the **Provincial IModel C1 Championships**, hereinafter referred to as ***the competition*** .

1.2 The competition shall be divided into the following divisions:

Under 13 Boys	For teams registered as Under 13 Boys
Under 13 Girls	For teams registered as Under 13 Girls
Under 14 Boys	For teams registered as Under 14 Boys
Under 14 Girls	For teams registered as Under 14 Girls
Under 15 Boys	For teams registered as Under 15 Boys
Under 15 Girls	For teams registered as Under 15 Girls
Under 16 Boys	For teams registered as Under 16 Boys
Under 16 Girls	For teams registered as Under 16 Girls
Under 17 Boys	For teams registered as Under 17 Boys
Under 17 Girls	For teams registered as Under 17 Girls

## 2 MANAGEMENT OF THE COMPETITION

---

2.1 The IModel Steering Committee shall be responsible for developing the rules, policies, and procedures governing the competition. The Chair of the IModel Steering Committee shall be accountable for the Competition Rules, Policies, and Procedures.

2.2 The Ontario Soccer staff shall be responsible for managing and implementing the operational functions of the competition. The staff shall be accountable to the CEO for these operational functions.

2.3 Protests shall be managed by the Provincial IModel C1 Championship Protest panel.

2.4 Discipline shall be managed by Ontario Soccer staff.

The IModel Steering Committee shall be the final decision maker on all issues related to the Competition. Decisions made by the IModel Steering Committee shall be deemed final and are not subject to an appeal process.

## 3 QUALIFYING FOR THE COMPETITION

---

3.1 Teams must have finished first in their respective IModel Competition 1 (C1) League (or be the League Designate should the winning team be unavailable) for the current season.

3.2 Teams must confirm their attendance upon notification with their respective League Administrator.

3.3 There is no entry fee for the competition



3.4 Teams participating in the Provincial IModel C1 Championships must have two uniforms of different colour at all Championship games to avoid colour conflicts. These uniform colours will be registered with Ontario Soccer.

## 4 FORMAT FOR THE COMPETITION

---

4.1 The competition be a single-game knock-out format with two Semi-Final games played and the winners of each Semi-Final advancing to the Final.

4.2 The League division winners will be drawn into the Semi-Final game positions. In the event that there are fewer than four (4) League division winners, a League division winner(s) will receive a bye and be drawn into the Final Round.

## 5 PLAYER ELIGIBILITY

---

5.1 For the competition, eligibility shall be defined as the following:

- A player that is listed on an Ontario Soccer team roster to that Club on or before July 31<sup>st</sup> 2025.
- A player that was used as a registered call up for that team at any point in the season is permitted, provided it was done in accordance with the IModel 2025 published Rules and Regulations. Proof of being a call-up in the competition must be provided upon initial team registration with Ontario Soccer.

5.2 A player shall **NOT** play for more than one team in the competition. Save for provision of proof to the contrary, a player whose name appears on the team sheet shall be deemed to have played in the game.

5.3 Each player and team official shall be identified on the team sheet, in accordance with the following procedures:

- A representative of each team shall, no later than 50 minutes prior to the kick-off time, hand to the Ontario Soccer Representative one copy of their team's team sheet.
- The team sheet shall list all eligible players (including potential substitutes) and up to five team officials.
- The team sheet must be signed by all players and team officials.
- After checking the team sheets for proper completion, the team sheet shall remain with the Ontario Soccer Representative until it is provided to the Match Officials prior to the commencement of the game.
- In each game of the competition, a team shall be permitted to dress and play up to 20 players.  
Only the 20 "dressed" players and the five team officials included on the team sheet may sit on the team bench or in the area designated for that team.

5.4 Unlimited substitution shall be permitted on own stoppages in play (must not significantly alter flow of play).



**5.5** Team sheets for the Provincial IModel C1 Championships will be available to the teams. Each team must print one copy of the team sheet for each game, which must include signatures of all players and team officials participating in the game.

If a *team sheet* is not available prior to the start of the game, a *substitute team sheet* may be used. The following information must be included on a *substitute team sheet*:

**5.6** Each player/team official must produce their Ontario Soccer Player ID before being eligible to participate in a game of this competition, subject to the following:

- The Ontario Soccer representative(s) shall inspect the Player/Team Official ID of both teams. In such cases, the Ontario Soccer representative(s) may declare a player ineligible to play in the game.
- When a team representative has reported a player eligibility discrepancy to the Referee (in accordance with Rules 5.6), the Referee shall have the player complete on the reverse side of the team sheet (regarding "player eligibility"), in which the player must write their date of birth and signature.

## 6 TEAM NO-SHOWS

---

If a team fails to appear at its scheduled Provincial IModel C1 Championship game:

- The team's Club shall:
  - o Pay the applicable Match Officials' fees and travel expenses
  - o Pay a penalty of \$1,000.00 to Ontario Soccer; and
  - o The manager and the coach of the team may be subject to further disciplinary action.

## 7 MATCH OFFICIALS

---

**7.1** A Referee, two Assistant Referees and a 4<sup>th</sup> Official shall be appointed to **each** Provincial IModel C1 Championship game.

**7.2** The Ontario Soccer Manager of Match Official Development is responsible for **appointing** the Match Officials to all games.

**7.3** All Match Officials officiating Provincial IModel C1 Championship games shall be a registered Match Official in good standing with Ontario Soccer.

**7.4** Match Officials must arrive a minimum of 1 hour prior to kick-off and report to the on-site Referee Coordinator.



7.5 Dress Code for Provincial IModel C1 Championships is "business casual".

7.6 The "**Match Officials Fees**" shall be paid in accordance with the following:

- Ontario Soccer shall be responsible for paying the "Match Officials Fees", upon completion of the Match Officials' duties, including the submission of the team sheets and all misconduct reports, and their attendance at discipline hearing(s).
- If for any reason, the game is not started, each Match Official present shall be paid one half of their "Match Official Fee"
- Reports must be completed by the Referee immediately after the game and submitted to the Event Coordinator at the game. The Referee shall also be required to attend the discipline hearing of any player dismissed during the game who requests a hearing. Such hearing shall take place within 30 minutes after it is requested and no later than one hour after the game.

## 8 DURATION OF PLAY

8.1 The duration of games will be:

Division	Regulation Time	Overtime

The Referee shall be the sole judge of the amount of time played and their decision on this matter **shall NOT** be subject to appeal or protest. Allowance shall be made in either period for all time lost through substitution, the transport from the field of injured players, time-wasting or other cause, the amount of which **shall** be a matter for the discretion of the Referee.

8.2 In the event that a game cannot be played for the full duration of time, the game shall be considered complete if at least two thirds of the allotted time has elapsed. This rule will not apply if the game does not run its full duration because the referee has abandoned the game as a result of the actions of one or both teams; and in such a case, the Provincial IModel C1 Championship Committee shall determine the status of the game. As the sole judge of the amount of time played, the Referee shall report how much time had lapsed before the game was terminated.

8.3 In accordance with 8.1, if the game is tied at the end of Regulation Time, a winner shall be determined by penalty shoot-out, in accordance with the current edition of the IFAB Laws of the Game.



## 9 TEAM RESPONSIBILITIES

---

9.1 The Home Team shall be designated on the draw chart.

9.2 The Teams must wear their registered main colours and if the colours of the two teams are similar (as judged by the Referee), the Visiting Team must wear alternate colours. The Home Team is only permitted to wear alternate colours to its main colours, providing that such colours are not similar to the colours worn by the Visiting Team. Only jersey colours will be considered a conflict and therefore, the team would only be required to change its jerseys. (NOTE: The main colours and alternate colours of each team have been registered with Ontario Soccer)

## 10 PROTESTS

---

10.1 Each protest arising from a Final in the competition shall be sent in accordance with the following policies and procedures:

- *By 12:00p.m. on the Tuesday following the game, the protesting club shall advise Ontario Soccer Provincial Office by:*
  - o Telephone (905) 264-9390 x227 or
  - o E-mail Robyn McComb - [rmccomb@ontariosoccer.net](mailto:rmccomb@ontariosoccer.net) or
  - o In person at Ontario Soccer office
- *Within **TWO** days (Saturdays, Sundays, and Legal Holidays excepted) of the conclusion of the game being protested, the protesting club shall send:*
  - o the written protest to Ontario Soccer's Office (7601 Martin Grove Road, Vaughan, Ontario, L4L 9E4) by:
    - registered mail or registered courier service or
    - hand delivery or
    - email to Robyn McComb - [rmccomb@ontariosoccer.net](mailto:rmccomb@ontariosoccer.net)
  - o the written protest shall include the following information:
    - the name of *protesting club*
    - date of game
    - game number
    - division
    - name of *club's team*
    - name of *opposing team*
    - rule(s) which were violated
    - additional information to support protest
    - name and position (within club) of person advising Ontario Soccer
- A protest fee in the amount of **\$250.00 must accompany the protest (if letter of protest is e-mailed, the fee must be received within five response days after the receipt of the e-mail)**  
*In cases of disputed delivery date regarding protests submitted by hand delivery or e-mail, it is the responsibility of the protesting Club to prove which date the protest was received at Ontario Soccer's Office.*



Please note that Ontario Soccer is not responsible for protests sent by e-mail that are not received by 12:00 p.m. on the Tuesday. In the event that a game has been rescheduled and is not played on a weekend, the protesting club shall advise Ontario Soccer Office by 12:00 p.m. two days following game.

**10.2** If the terms of **Rule 10.1** are not met, the protest shall be declared to be out of order .

**10.3** The *protesting club* must provide evidence to substantiate the protest.

**10.4** Upon receiving the initial notification of the protest (*in accordance with Rule 10.1 a* ), Ontario Soccer staff shall notify the League Representative (or an alternate person in that District Association) of the *opposing team's club* about the nature of the protest. The league Representative (or the alternate person) shall advise the *opposing team's club* about the nature of the protest.

**10.5** Upon receiving the written protest, (*in accordance with Rule 10.1 b*) , the Ontario Soccer staff shall provide the opposing team's club with a copy of the Protest.

**10.6** Protests shall be dealt with by the *Provincial IModel C1 Championships Protest Committee* .

**10.7** After the protest is received, the hearing will be scheduled and the date and time will be communicated to all parties.

**10.8** Officials from both clubs/teams and both League Representatives have the right to send written submissions to the Ontario Soccer's Office regarding the protest. Such submissions shall be considered by the *Provincial IModel C1 Championships Protest Committee*. Additional information will be considered providing it arrives **two hours** prior to the scheduled meeting of the *Provincial IModel C1 Championships Protest Committee* .

**10.9** All written submissions being considered by the Committee will be disclosed to both the protesting team and the opposing team prior to the hearing.

**10.10** The *Provincial IModel C1 Championships Protest Committee*, in reviewing the protest, shall consider all written submissions including:

- the written protest from the *protesting club*
- any submissions received *in accordance with Rule 10.7*
- the Match Official's report
- any other submissions received

and shall render a decision based on the evidence presented and there shall be no further appeal of any kind against its decision(s).

**10.11** Notwithstanding **Rule 10.8** , at its discretion, the *Protest Committee* may convene a *protest hearing* at which officials from both clubs/teams, the match officials, or other persons may be required to attend. There shall be no further appeal of any kind against its decision(s).

**10.12** In the event a team is found to be in *contravention of the competition rules* as a result of a protest, the *Protest Committee* has the authority to:

- decide, on the basis of the evidence provided, which team (if any) will be declared the winner of the game; and / or



- levy a fine against an *offending team* to a maximum of \$1,000.00 per game.

**10.13** Each protest arising from a Semi=Final in the competition shall be sent in accordance with the following policies and procedures:

- *Within 30 minutes of the conclusion of the game being protested, the protesting Club shall submit:*
  - o the written protest to the Ontario Soccer Representative at the competition
  - o a protest fee in the amount of **\$250.00**
- *The Ontario Soccer Representative shall notify the opposing team that the game has been protested and shall advise it about the details and grounds on which the protest is based.*
- *The Ontario Soccer Representatives shall convene a Protest Hearing within one hour after the receipt of the protest*
- *Both teams shall be invited to send a representative(s) to the Protest Hearing and the Ontario Soccer Representative(s) may invite other persons to provide testimony at the Protest Hearing*
- *The Protest Hearing Panel shall consist of a minimum of three persons which shall consider all testimony and reports presented to them; and shall render a decision; and there shall be no further appeal of any kind against its decision(s)*
- In the event that a team is found to be in contravention of the competition rules as a result of the protest, the Protest Hearing Panel has the authority to:
  - o decide, on the basis of the evidence provided, which team (if any) will be declared the winner of the game; and / or
  - o levy a fine against an *offending team* to a maximum of \$1,000.00 per game.

**10.14** Protests will not be entertained if the issue is, according to the laws of the game, at the discretion of the referee (i.e. field conditions)

## 11 RULE CONTRAVENTION WITHOUT PROTEST

---

**11.1** Notwithstanding **Rule 10.0** , the *Protest Committee* may:

- reverse a game result of a team for that team's *contravention of a competition rule(s)* , even if a protest has not been lodged correctly, or lodged at all,
- fine a team,
- take any other disciplinary action deemed appropriate by the Committee.

## 12 DISCIPLINE

---

### 12.1 Jurisdiction

**12.1.1** The *Provincial IModel C1 Championships Discipline Committee* shall be responsible for handling all cases of reported misconduct with the exception of:

- **Match Official Assault;**
- Physical assault or attempted physical assault of a youth aged player by a team official or administrator immediate discipline of players at games played.



**12.1.2** It is the responsibility of each Club to ensure that its Players and Team Officials are aware of the Provincial IModel C1 Championships Discipline rules and of the discipline systems used at the competition

## 12.2 Discipline Systems

**12.2.1** Discipline shall be rendered in accordance with the **Discipline by Review (D.B.R.)** system for all Misconduct Types listed in **12.6.1** and some sections in **12.6.2**

**12.2.2** All other misconduct shall be referred to Ontario Soccer and discipline shall be rendered in accordance with the **Discipline By Hearing (D.B.H.)** system with penalties as specified in Discipline Section 9.0

**12.2.3** *Provincial IModel C1 Championships Discipline Hearing/Review Panel* shall be appointed by Ontario Soccer and shall use the **Discipline by Review (D.B.R.)** system to review all cases of **player** misconduct reported by a match official, **except for:**

- **Match Official Assault;**
- Misconduct by a **player** which occurred in their team's last game in the Championships, unless the player requests a Discipline Hearing;
- Misconduct which falls under the **Discipline By Hearing (D.B.H)** System;

and shall render discipline in accordance with the mandatory suspensions, as specified in **12.6.1**

**(Note: Except for Match Official Assault or physical assault/attempted physical assault of a youth registered player by a team official or administrator, there shall be no discipline rendered for team officials or administrators at the Competition )**

## 12.3 Reporting and Review of Discipline

**12.3.1** Ontario Soccer shall review all cases of reported misconduct and shall render discipline in accordance with the mandatory penalties, as specified in **Rule 12.6.1** , after taking into consideration the number of games suspended at the Championships, in accordance with **Rule 12.3.1**, or the number of games suspended at the Championships

**12.3.3** In the event that (based on the reports which it reviews) the *Discipline Committee* decides that additional misconduct has occurred or that a Serious Foul Play or Violent Conduct misconduct warrants more than the mandatory suspension, it shall advise the person (either directly or through his/her Club) that additional charges are being laid and that a *Discipline Hearing* is being scheduled in accordance with the following procedures:

- The discipline hearing shall be heard by an *Discipline Hearing Panel* prior to the next game being played
- If the *Discipline Hearing Panel* finds the accused guilty of the reported misconduct, discipline shall be rendered in accordance with **Ontario Soccer Discipline Policy 9.0**

## 12.4 Request for Discipline Hearing

**12.4.1** An accused **Player** subject to **Discipline by Review** has the right to request a **Discipline Hearing:**



- a. Such request, and subsequent hearing, must adhere to the following procedures:
  - o The request may pertain to any game, except the last game of the player's team in the Championship. Requests pertaining to the last game of the player's team shall be made in accordance with Rule 12.4.1 b);
  - o the *Request For A Hearing* must be made **in writing**
  - o the request must be submitted within **30 minutes** after the conclusion of the game in which the player committed the alleged misconduct
  - o a **\$250.00 Request For Hearing Fee** must be included with the request)
  - o the *Discipline Hearing* must convene within **30 minutes** after receipt of the request.
  - o the player must attend the hearing. The Referee must attend the hearing if requested by the discipline hearing panel
  - o the player may not participate in any soccer activities until the decision of the *Discipline Hearing Panel* has been communicated
- b. For the last game of a player in the competition, such requests must adhere to the following procedures:
  - o the accused or their Club's representative must advise Ontario Soccer of the intent to request a hearing by one or more of:
    - telephone to (905) 264-9390
    - e-mail to – [appealcasemanager@ontariosoccer.net](mailto:appealcasemanager@ontariosoccer.net)
    - in person at the *Ontario Soccer's Office*
  - o **by no later than 3:00 p.m. on the first Monday** following the game in which the alleged misconduct occurred
  - o the *Request For A Hearing* must be forwarded in writing, by *registered mail, certified mail, trace mail, or courier service* **within one day of the conclusion of the match** in which the alleged misconduct occurred, to the *Ontario Soccer's Office*
  - o a **\$250.00 Request For Hearing Fee** must accompany the *Request For A Hearing*
  - o the *Discipline Hearing* shall be heard by a *Discipline Hearing Panel*
- If the *Discipline Hearing Panel* finds the player to be **not guilty** of the reported misconduct, the player shall be refunded their *Request For Hearing Fee* minus an Administrative fee.

**12.4.2** An accused **Coach or other Team Official** subject to **Discipline by Review** has the right to request a **Discipline Hearing**:

- a. Such request, and subsequent hearing, must adhere to the following procedures:
  - o The request may pertain to any game, except the last game of the team official's team in the Championship. Requests pertaining to the last game of the team official's team shall be made in accordance with Rule 12.4.2 b)
  - o the *Request For A Hearing* must be made **in writing**
  - o the request must be submitted within **30 minutes** after the conclusion of the game in which the coach or team official committed the alleged misconduct
  - o a **\$250.00 Request For Hearing Fee** must be included with the request
  - o the *Discipline Hearing* must convene within **30minutes** after receipt of the request
  - o the coach or team official must attend the hearing. The Referee must attend the hearing if requested by the discipline hearing panel
  - o the coach or team official may not participate in any soccer activities until the decision of the *Discipline Hearing Panel* has been communicated
- b. For **all other games** such requests must adhere to the following procedures:



- o the accused or their Club's representative must advise Ontario Soccer. of the intent to request a hearing by one or more of:
    - telephone to (905) 264-9390
    - e-mail to – [appealcasemanager@ontariosoccer.net](mailto:appealcasemanager@ontariosoccer.net)
    - in person at Ontario Soccer's Office
  - o **by no later than 3:00 p.m. on the first Monday** following the game in which the alleged misconduct occurred
  - o the *Request For A Hearing* must be forwarded in writing, by *registered mail, certified mail, trace mail, or courier service* **within one day of the conclusion of the match** in which the alleged misconduct occurred, to Ontario Soccer's Office
  - o a **\$250.00 Request For Hearing Fee** must accompany the *Request For A Hearing*
- If the *Discipline Hearing Panel* finds the coach or team official to be **guilty** of the reported misconduct, the mandatory discipline shall be rendered, in accordance with [Rule 12.6.2](#)

If the *Discipline Hearing Panel* finds the coach or team official to be **not guilty** of the reported misconduct, the *Request For Hearing Fee* minus an Administrative fee shall be returned.

**12.4.3** Failure to request a *Discipline Hearing* , in accordance with [Rule 12.4.1](#) or [Rule 12.4.2](#) shall mean that any suspension levied under the *Discipline By Review (D.B.R.)System* may **NOT** be appealed to Ontario Soccer or any other organization.

## 12.5 General Discipline Rules

**12.5.1** In all cases of **Match Official Assault** , the accused shall be immediately **suspended from all soccer activities** , the report shall be referred to Ontario Soccer and discipline shall be handled by an *Ontario Soccer Discipline Hearing Panel* , in accordance with Ontario Soccer's Published Rules.

**12.5.2** In cases where a team official or administrator is reported by a Match Official, or if charges are laid by the police, for Physical Assault or Attempted Physical Assault of a youth registered player, the team official or administrator in question shall be immediately **suspended from all soccer activities** and discipline shall be handled by an *Ontario Soccer Discipline Hearing Panel* , in accordance with Ontario Soccer Published Rules

**12.5.3** In a case of *mistaken identity* , the accused person must prove to the *Discipline Hearing Panel* at a *Discipline Hearing* that they were incorrectly identified and must identify and prove the **correct identity** of the player/team official who actually committed the reported misconduct; and in such case the player/team official will not be suspended but the player/team official who actually committed the reported misconduct shall be disciplined, in accordance with [Rule 12.6.1](#) or [12.6.2](#)

## 12.6 Mandatory Penalties

**12.6.1 a) Players** : For the Misconduct Types found on Table 5 of [section 9.0 of the Published Rules](#) and occurring in Provincial IModel C1 Championship games, discipline shall be rendered under the *Discipline by Review* system and the mandatory penalties as outlined in Table 5 shall apply. Where suspensions in Table 7 of [section 9.0 of the Published Rules](#) are quoted as a range, application of a suspension within the range is required and the misconduct will be dealt with under the *Discipline by Hearing* system.

b) If the match official's report indicates that a charge of 1.16A is justified, the Review Hearing Panel will deal with the player under 1.16 and forward the report to the Provincial IModel C1 Championship Discipline Committee for further disciplinary action at a subsequent hearing. If the match official's report indicates that



there was intent to injure i.e. types 1.19A and 1.21A, the Review Hearing Panel will deal with the player under types 1.19 and 1.21 and forward the reports to the Provincial IModel C1 Championship Discipline Committee for further disciplinary action at a subsequent hearing.

c) For the Misconduct Types found on Table 6 of [section 9.0 of the Published Rules](#) and occurring in Provincial IModel C1 Championship games, discipline shall be rendered under the *Discipline by Hearing* system and the mandatory penalties as outlined in Table 6 shall apply. This discipline shall be referred to Ontario Soccer and handled by an Ontario Soccer Discipline Hearing Panel.

#### 12.7.4 In the case of "*suspensions for a specific number of games*":

- A player suspended for a specified number of games shall serve such suspension in the Provincial IModel C1 Championships competition (i.e. shall be suspended from a specific number of games) until the player's team has concluded its participation in that year's Championships. After a team has concluded its participation in that year's Championships, the player's remaining number of suspended games shall be served in their team's league in the following season.
- For each player who has a remaining number of suspended games to be served after their team has concluded its participation in that year's Championships, Ontario Soccer shall transfer the suspended games (still to be served) to the team's league and/or District Association shall designate the specific games in that league from which the player will be suspended the following season.

### 12.8 Fines, Bonds and Penalties

12.8.1 In the event a team, including team officials, contravenes the *competition rules* as contained herein, the **Provincial IModel C1 Championships Committee** and/or the **Discipline Hearing/Review Panel**, has the authority to levy fine(s) against the offending team, up to a maximum of **\$1,100.00** per game.

12.8.2 A club representative required to attend a discipline hearing for one of its players, coaches or administrators who fail to appear at the hearing will be fined \$200.00 for non appearance.

12.8.3 If a game is abandoned due to the action(s) of its players, coaches, administrators or spectators and such actions are warranted as invalid reason(s) for abandoning the game, the IModel Steering Committee may declare a team ineligible to enter the Provincial IModel C1 Championships in the subsequent year and the team will be fined in accordance with [Discipline Policy 9.0](#) Table 9

### 12.9 Forfeiture of Game

12.9.1 In cases of severe team misconduct, the Provincial IModel C1 Championships Discipline Hearing Panel has the authority to **reverse a game result of a team**
