Minutes– Minutes from the June 15 board meeting were reviewed. **(Motion to approve minutes by Tiffany, 2nd by Mike, motion passed.)**

Requests/Action:

Funding Requests – Coach Hancock presented his funding request for new mini banners for the boys’ track team to be hung in the Field House and discussed getting checks to Cougar Club for registration fees for last track meet. Amount requested was \$125.00.

Coach Pryor also had a funding request though he was not present. Coach Pryor’s funding request was discussed by the Board. The funding request was for the District Championship banner for girls’ soccer, in the amount of \$195.00.
