

# **SUPER Y LEAGUE PLAYER FAMILY SURVEY** **SWEEPSTAKES OFFICIAL RULES**

## **NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

The Super Y League Player Family Survey Sweepstakes (the “**Contest**”) is a contest sponsored by United Soccer Leagues, LLC (the “**Sponsor**”) and governed by these official rules (the “**Official Rules**”). By participating in the Contest, each person entering the Contest (“**Entrant**”) agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the Contest, as determined by Sponsor and its agents, are final in all respects. The Contest is subject to all federal, state and local laws and regulations and is void where prohibited by law.

### **ELIGIBILITY**

The Contest is open to parents of Super Y League Players who are legal residents of the continental United States and Canada (excluding Quebec) where not prohibited by law, who are eighteen (18) years of age or older at the time of entry, and who have Internet access prior to the beginning of the Contest Period (as described below). Sponsor has the right to verify the eligibility of each Entrant. Employees of Sponsor, its advertising and promotion agencies involved with this Contest, and their respective subsidiaries, divisions, affiliates and related companies, and the immediate family members and/or those living in the same household of such employees, are not eligible to participate or win. To be eligible for the drawing, entries must be received and recorded by Sponsor during the Contest Period.

### **CONTEST PERIOD**

The Contest Period is the time during which submissions may be received. The Contest Period begins on November 18, 2019 and will close 5:00 pm EST on January 2, 2019. During this time, Entrant can submit an entry to the Contest on Sponsor’s official Super Y League website (see How To Enter, below). Sponsor reserves the right to extend or shorten any or all Contest Periods in its sole discretion. Sponsor's computer is the official clock for this Contest.

### **HOW TO ENTER**

Enter the Contest by completing the Player Family Survey in full (“**Contest Entry**”) on [www.sylsoccer.com/player-family-survey](http://www.sylsoccer.com/player-family-survey). Entry is limited to one per Super Y League player household.

### **ALTERNATE METHOD OF ENTRY**

### **WINNER SELECTION**

The winner will be chosen by the following process. At the outset, ineligible Entrants will be disqualified. Then, the Sponsor will determine the winner through a random selection process (the “**Winning Entrant**”). Where required by law, the potential winner will be required to answer a skill-testing question in order to win.

The Winning Entrant will be notified after Contest close. Notification and instructions for collecting the prize will be sent to the e-mail address supplied on the Winning Entrant's entry form. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential Winning Entrant for any reason.
