

ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING TO COVID-19

The health and well-being of our summer camp participants, coaches, visitor, and families remains our top priority. To minimize the risk of COVID-19 entering our environment and spreading among our community, we will only allow coaches and athletes in the field at the scheduled time of their sessions. No spectators will be allowed on the field.

Furthermore, all participants in activities at Club Ace Long Island (CALI) must agree to and abide by the following.

- If the player or parent is sick, please do not come to the tryout
- Players must wear their masks until they get to their court.
- All players, coaches, and visitors must use hand sanitizer or wash their hands before entering the court, at water breaks, and after leaving the court.
- Staggered court layout, as needed, to increase the distance between groups.
- The temperature will be taken upon arrival with contactless forehead thermometers for players, coaches, and parents. Everyone will also be asked screen questions
- Players, coaches should bring their own water and food, no water fountains will be open
- Hand sanitizer will be available; however, it is strongly suggested that players, coaches, visitors bring their own.
- Players and Coaches may arrive no more than 15 minutes before their activity start and must be picked up/leave no more than 15 minutes after their activity concludes
- Coaches are to stay with their group of players until they are released to exit
- There will be no spectators allowed including parents

Club Ace Long Island CALI has put in numerous preventative measures and enhanced cleaning protocols all materials to reduce the likelihood of spreading COVID 19 in our environment; however, Club Ace Long Island CALI cannot guarantee that you or your child will not become infected with COVID-19. Further, attending activities at any CLUB ACE LONG ISLAND camps could increase you or your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntary agreement to the participation terms described above and assume the risk that my child and I may be exposed to or infected by COVID-19 by attending activities at any Club Ace Long Island control and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Club Ace Long Island camps, clinics and or privates may result from the action, omission, or negligence of myself and others, including, but not limited to the club employees, volunteers, coaches, players, and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself(including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim liability or expense of any kind, that I or my child(ren) may experience or incur in connection with our attendance at the Club Ace Long Island activities.

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Club Ace Long Island, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, cost or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any claims based on the actions, omission, or negligence of the Club Ace Long Island its employees, agents, and representations, whether a COVID-19 infection occurs before, during, or after participating in any activity at Club Ace Long Island event.
