

## Welcome back to the Arctic Coliseum everyone!

Below is information you will need to know before you enter our facility. These guidelines are designed to keep everyone safe and healthy.

### PRIOR TO AND UPON YOUR ARRIVAL

- If you feel ill or experiencing COVID-19 symptoms, please do not enter the facility
- **Everyone entering the building must be wearing a face mask and it must remain on for the entirety of your visit. Facemasks will not be provided.**
- Do not arrive more than 30 minutes prior to your ice time.

### DURING YOUR VISIT

- The Arctic Coliseum front entrance will have a designated “Entrance” and “Exit” signs, please follow the signs to help abide by social distancing rules.
  - There will be a check in table where you will have your temperature checked and asked a couple of questions upon entering
  - Please proceed to either your locker room or the designated arena that your event will be held. **Do not congregate in the lobby.** If in the lobby, please practice social distancing.
  - Please practice social distancing throughout your visit.
  - Locker rooms will be available, but we encourage all ice users to come dressed as much as possible. **Please follow the social distancing markings inside of each locker room.**
  - The water fountain will not be available for individual use. Only for water bottle refilling. Players must bring their own water bottle and it must be clearly marked with their name on it. No sharing of water bottles or any equipment.
  - The Arctic Coliseum is a tobacco free facility which includes no chewing tobacco
  - No spitting anywhere in our facility, this includes the ice, benches, locker rooms etc. We have added paper towel dispensers and waste baskets at the bench to help with this.
  - **Showering will be allowed as long as players social distance**
  - No outside food or beverage
  - There will no longer be a lost & found
  - Please practice social distancing while sitting in the stands.
  - There will be hand sanitizing stations in the lobby, locker rooms and inside each bathroom. Please utilize the sanitizing stations while inside the facility following the CDC guidelines.
  - **Players/Coaches and guests must depart as soon as possible after the conclusion of their ice time.** This will help us to spend time running the ROOM STERILASER UV Light System in the locker rooms and clean as well.
  - Please exit through the right-side set of doors when leaving the facility.
- We are following the current spectator guidelines of 2 guests per player & coach

### ON-ICE GUIDELINES

Per the [MDHHS Emergency Order – Gatherings and Face Mask Order \(October 29, 2020\)](#), facial coverings are required in hockey. This includes athletes and coaches, at all times during active participation and all times during non-active participation, when 6 feet of physical distance cannot be maintained. In both practices and training sessions, in all MERC regions of the state, the Emergency Order applies

- MDHHS Emergency Order – Gatherings and Face Mask Order (October 29, 2020) does not define ‘facial coverings’ for purposes of organized sports; however, facial coverings must cover the nose and mouth. The following are not prohibited by the MDHHS Emergency Order – Gatherings and Face Mask Order (October 29, 2020):
  - Traditional cloth / fabric masks (worn on the face, covering nose / mouth)
  - Neck gaiters (worn on the face, covering nose / mouth)

- [Statement from the Hockey Equipment Certification Council \(HECC\) – click here for full version](#):
  - HECC has determined that any modification to the helmet will void the helmet's certification. This would include any Spit Guard that is applied to the helmet, or any Spit Guard that replaces the components of the approved helmet.
  - A helmet modified with any Spit Guard must be verified by HECC with that modification. It is HECC's position that:
    - a) The original helmet manufacturer must approve the use of the Spit Guard with its product, AND;
    - b) The modified product must be verified by the HECC validator to ensure that it still meets the applicable test standard
- ➤ Without meeting these two requirements, the HECC Certification is voided by the addition of the Spit Guard.
