2. It is also understood that the fee does not include medical insurance coverage. All applicants must have Ontario Health Insurance, protection pads, soccer shoes and must behave in a sportsman-like manner at all times.
3. In the event that a player becomes unable to continue for whatever reason, USC "Karpaty" in its sole discretion may refund a portion of the fees.
4. Each player is to adhere to the USC Karpaty - Code of Behaviour, and any conduct unbecoming a player will be disciplined up to the exclusion from the team/club without the refund.
5. In the event that a player will be absent, notice should be given as soon as possible.
6. All images (still photo, digital images, and recordings) during practice, tournaments or games may appear in media or print.
7. Make cheque payable to "USC Karpaty".

Description of Risks:

- Injuries from executing strenuous and demanding physical techniques in soccer;
- Injuries from dry land training including weights, running, and massage;
- Injuries from grass, turf and other surfaces including bacterial infections and rashes;
- Injuries resulting from falls to the ground due to uneven or irregular terrain or surfaces;
- Injuries from collisions with walls and soccer equipment;
- Injuries resulting from failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment;
- Spinal cord injuries which may render me permanently paralyzed;
- Injuries from extreme weather conditions which may result in heatstroke, sunstroke or hypothermia;
- Injuries from contact, colliding or being struck by other participants, spectators, equipment or vehicles;
- Injuries resulting from vigorous physical exertion and strenuous cardiovascular workouts;
- Injuries from exerting and stretching various muscle groups; and
- Travel to and from competitive events and associated non-competitive events which are an integral part of the organization's activities.
- Furthermore, I am aware:
- That injuries sustained in soccer can be severe;
- That I may come into close contact with other participants, including the possibility of accidental and unexpected contact;
