PURPOSE:

To establish the guidelines for team practice(s) at the LCSC complex.

POLICY:

It is the policy of Logan County Soccer Club that teams will not use the game fields for regular practices. Teams are allowed (1) one free scheduled practice, any remaining team practices are not to be held at the LCSC soccer complex. If additional practices are requested, beyond the (1) one free, to be held at the complex these practices will be associated with a usage fee.

SCOPE:

RESPONSIBILITY:

Coaches, Board of Directors, Logan County Soccer Club

PROCEDURE:

1. Coaches will contact the 3rd Vice President to schedule practice session(s) for each team at the LCSC soccer complex. All field reservations are on a first come first serve basis. All reservations are recommended to be made 72 hours in advance. If reservations are not finalized and the field is utilized the team will then be charged with (3) three practice times and associated fees.
2. If there is a scheduling conflict, the 3rd Vice President and the scheduled team will reschedule the practice session for another date.
3. Any in-house team utilizing the LCSC soccer complex for non-approved practices will forfeit (1) one game for each occurrence during the spring season when standings are held.
4. Any in-house team utilizing the LCSC soccer complex for non-approved practices will be suspended from their next scheduled game during the fall season when standings are not held.
5. Any traveling team utilizing the LCSC soccer complex for non-approved practices will be suspended from their next scheduled game during any season. The 2nd Vice President will send notification to the associated governing body of LCSC informing them of the disciplinary action and ensuring that the suspension will be recorded on the offending team's final season record.

6. Additional practices at the facility, beyond the (1) one free practice, can be reserved with an associated fee. The most fees that can be charged to a team's account at any given time is (3) three practice fees. Any fees encumbered beyond (3) three will place the team in bad standings and the disciplinary action associated will be left to the discretion of the LCSC Board of Directors. The fee schedule is as follows:
 - a. U4-U8 = \$20
 - b. U9-U10 = \$25
 - c. U11-U12 = \$30
 - d. U13-U19 = \$35
7. Board Members and/or coaches may utilize board member passes and/or coaching passes as payment toward field usage fees. Each Board Member pass and/or coach pass counts for two (2) free practices at the fields.
8. During the fall season the LCSC Board of Directors will grant two free practices, on a first come first serve basis including meeting the 72 hour reservation requirement, to any team during the week of the Bluegrass Festival.
9. Any coach that has three (3) disciplinary actions recorded with LCSC and/or any LCSC associated governing body the offending coach may be banned from LCSC. Notification of removal of the coach from LCSC will be sent to all LCSC associated governing bodies.
10. No team practices will be allowed on Friday's in order for the fields to be vacant so that field preparation can be completed for the upcoming weekend games.
