  - a. **ARTICLE VI. DISSOLUTION**  
WAYA is organized exclusively for charitable, recreational, and/or educational purposes under section 501 (c) (3) of the Internal Revenue Code.  
  
In the event of the dissolution of the WAYA, all of the assets, after payment in full of all its debts and obligations of whatsoever kind and nature, shall be donated and divided evenly between the Whitehall Elementary / Intermediate Physical Education Program and the following municipalities for field upkeep: The City of Whitehall, Village of Pigeon Falls and Town of Hale/Pleasantville Lions or for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
8. Membership Fees/Uniforms
  - a. \$35/player \$140/Family per year
  - b. Baseball and Softball Uniform fees 8U and above paid for by family; T-ball (uniform (t-shirt) included in membership fee)
  - c. Other fees may be associated with each sport (tournament entry fee, clinic fee, etc)
  - d. Reminder: Membership year will now run from July 1- June 30 (approved in February 2018)
