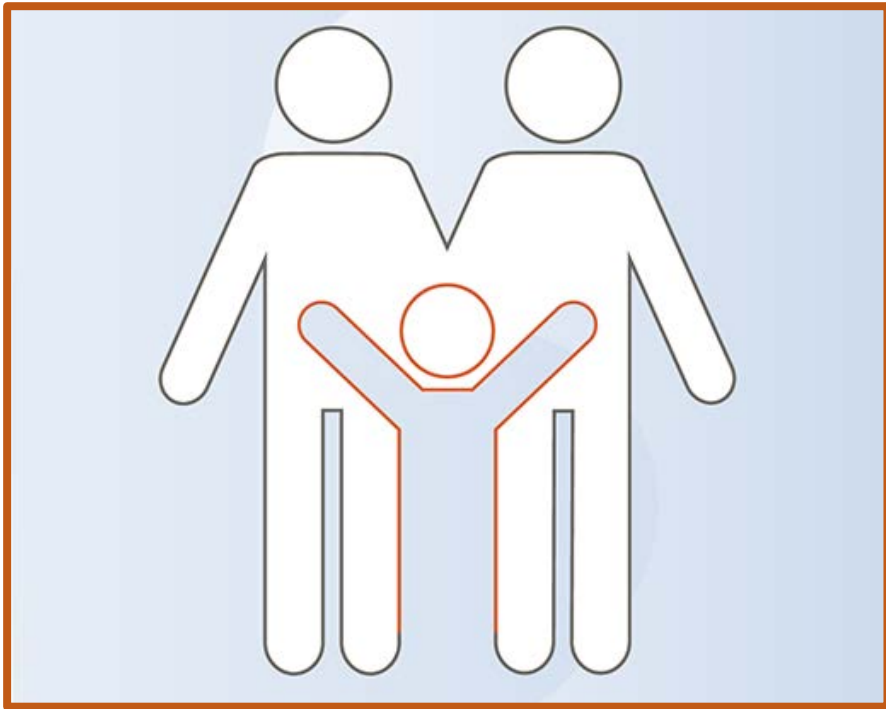

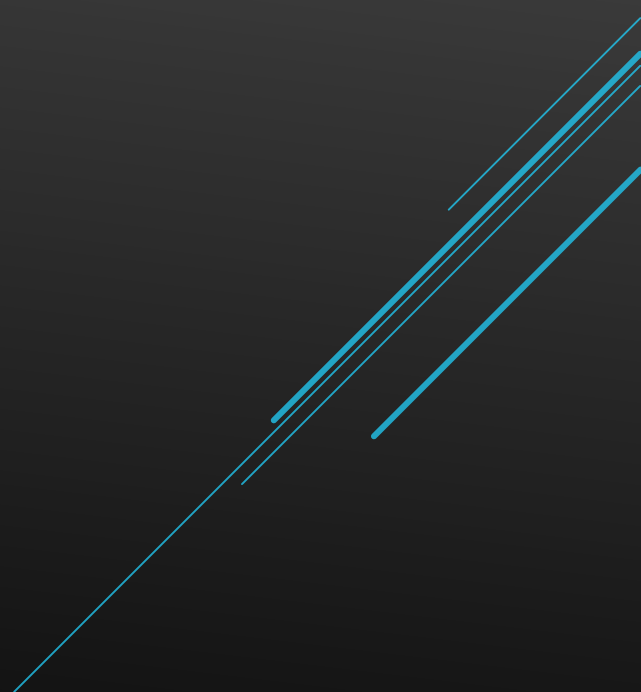

AIDING & ABETTING – CODE OF CONDUCT

Any act taken with the purpose of facilitating, promoting, or encouraging the commission of Prohibited Conduct by a Participant. Aiding and abetting includes without limitation:

- ▶ Allowing any person who has been identified as permanently suspended by Center to be in any way associated
- ▶ Aiding or abetting the coaching or instruction of athletes by any person who has been identified as permanently suspended or ineligible by the Center
- ▶ Allowing any person who has been identified as permanently suspended or ineligible by Center to have ownership interest
- ▶ Providing any coaching-related advice or service to an athlete

- ▶ *Related to ENFORCEMENT
